

FY 2024 Quarter 2 (April - June)







OVERVIEW

The Quarterly Debt Bulletin summarizes the public debt position, public debt structure and public debt ratios for Anguilla as at the end of quarter in review with quarterly and yearly comparisons. Anguilla's public debt is governed by the Fiscal Responsibility Act and Framework for Fiscal Sustainability and Development.

NTRODUCTION

Quarterly Debt Bulletins seek to make the government's debt management reporting clear and accessible to all with an aim to facilitate discussion and influence informed decisions among policymakers, the public, and other stakeholders. The bulletin's presentation is in a comprehensive yet digestible format that includes infographics, charts, table and graphs with explanations to complement.

The currency quoted is in millions of Eastern Caribbean Dollars (XCD/EC\$M). All instruments and securities denominated in foreign currencies have been converted to Eastern Caribbean Dollars given the official quoted exchange rate on the last day of the reporting quarter.

The debt statistical bulletins are published quarterly (for quarters ending March, June, September and December).

OUARTERLY DEBT BULLETIN

Total Public Debt as at 30th June 2024 stood at 1. \$352.74m. Total Public External Debt was 40.22% (\$141.86m) of total public debt. This represented a decrease of 3.15% (\$4.61m) and 12.89% (\$20.99m) when compared to Q1-2024 and Q2-2023 respectively. Total Public Domestic Debt accounted for 59.78% (\$210.88) of total public debt. This amount decreased by 1.91% (\$4.10m) and 7.76% (\$17.73m) in comparison to Q1-2024 and Q2-2023 respectively. Central Government debt accounted for 99.86% of total public debt and the remaining 0.14% related to government guaranteed and non-guaranteed debt of SOEs.

Figure 2: TOTAL PUBLIC DEBT COMPOSITION, Q2-2024






Figure 3: PUBLIC DEBT BY BORROWER, Q2-2023 to Q2-2024



2. Central Government Debt totaled \$352.26m at the end of Q2-2024, an increase of \$4.50m (1.29%) and a decrease of \$23.50m (6.25%) when compared to Q1-2024 and Q2-2023 respectively. Domestic debt accounted for 59.87% (EC\$210.88m) and external debt accounted for 40.13% (EC\$141.38m) respectively.



2.1 Central Government External Debt accounted for 40.13% (EC\$141.38m) of Central Government debt at the end of Q2-2024. There was a decrease of \$4.57m (3.13%) and \$20.28m (12.55%) when compared to Q1-2024 and Q2-2023 respectively. The main external creditor was the Caribbean Development Bank (CDB) and the main loan currency was the United States Dollar, both corresponding to \$140.96m of the debt at the end of Q2-2024. The remaining portion of external debt amounted to \$0.42m, which was denominated in Euro. The variable interest rate debt accounted for \$139.90m (98.95%), while fixed interest rate debt accounted for \$1.48m (1.05%). There were no external debt arrears.

2.2 Central Government Domestic Debt was recorded at \$210.88m at the end of Q2-2024. This represented an increase of \$9.08m (4.50%) and a decrease of \$20.28m (1.50%), when compared to Q1-2024 and Q2-2023 respectively. The Eastern Caribbean Dollar was the main loan currency of Central Government Domestic Debt. The main creditor category was government related institutions, specifically the Anguilla Social Security Board (ASSB), which held 84.99% (\$179.23m) of debt, 8.76% (\$18.49m) is associated with a private arrangement, the Depositors' Protection Trust² (DPT), and the residual 6.25% (13.71m) is related Public-Private Partnership (PPP) to the arrangement with Seven Seas Water. In regard to domestic instruments, the ASSB Promissory Note accounted for 84.99% of the domestic debt portfolio, the DPT bond accounted for 8.76% and the PPP accounted for the remaining 6.25%. There was no debt associated with the overdrafts. Additionally, there were no arrears related to domestic debt.

Figure 8: CENTRAL GOVERNMENT DOMESTIC DEBT BY INSTRUMENT, Q2-2024




² DPT- an arrangement established under the Bank Resolution Obligations Act and executed to protect and repay persons holding large deposits at the former National Bank of Anguilla Ltd. & the Caribbean Commercial Bank (Anguilla) Ltd.

¹ Fixed- Represents external debt denominated in foreign currencies to which the EC dollar is pegged and thus the exchange rate is fixed. The EC dollar is solely pegged to the US Dollar.

Floating- Represents external debt denominated in currencies to which the EC dollar is not pegged.

2.3 Central Government Debt Service amounted to \$12.78m during Q2-2024, a decrease of 0.65% (\$0.08m) when compared to Q1-2024 and an increase of 0.23% (\$0.03m) when compared to Q2-2023. Interest payments accounted for \$3.25m and amortization accounted for \$9.53m, which is 25.40% and 74.60% of total debt service respectively. Domestic debt service represented 43.52% (\$5.56m) of the actual debt service for Q2-2024 and external debt service, the remaining 56.48% (\$7.22m).

Note that the table below does not present the repayment currency and all monies were converted to Eastern Caribbean Dollars.

³The PPP arrangement between Seven Seas Water and the Water Corporation of Anguilla has been assumed by Central Government as of 1st April 2024 when the Water Corporation of Anguilla ceased to operate as a State-Owned Enterprise and was brought under Central Government as the Department of Water Services.

2.4 Central Government Disbursements

Disbursements totaled \$0.87m at the end of Q2-2024. These disbursements were on the Anguilla Community College Loan contracted from the CDB in 2014.

3. Guaranteed and Non-Guaranteed Debt stood at \$0.48m at the end of Q2-2024. There was a decrease of \$13.21m (96.52%) and \$15.22m (96.96%) when compared to Q1-2024 and Q2-2023 respectively. External debt accounted for \$0.48m (100%) and the sole creditor of external debt was the CDB. There were no domestic debt as the Public-Private Partnership (PPP) arrangement with Seven Seas Water has been assumed by Central Government.³ There were no disbursements made during Q2-2024.






Figure 11: TOTAL GUARANTEED AND NON-GURANTEED DEBT COMPOSITION, Q2-2024







4. Debt Ratios and Sustainability Indicators

One of the sustainability indicators, Debt/GDP, for Q2-2024 reflects a decrease in nominal debt stock of 0.53 percentage points and 8.09 percentage points when compared to Q1-2024 and Q2-2023 respectively. At the end of Q2-2024, Anguilla remained in compliance with the ECCU Debt target of 60% by 38.29 percentage points. The Average Time to Maturity (ATM) stood at 5.59 years and the Average Time to Refixing (ATR) stood at 4.35 years. The share of interest rate subject to refixing within one year was 79.32%.

Figure 12 portrays the maturity structure of Anguilla's public debt stock at the end of Q2-2024. The maturity profile is the amount of debt falling due in each period. Anguilla's existing debt is due to fully mature in 2041.

The graph illustrates that \$62.96m will mature in less than one year, \$147.79m within 5 years and \$141.99m over 5 years. Figure 12 indicates that external debt is due to fully mature in 2036 and domestic debt is due to fully mature in 2041.

Figure 12: TOTAL PUBLIC DEBT- MATURITY PROFILE



At the end of Q2-2024 preliminary estimates indicated that the GoA remained in breach of one of the three FFSD targets/benchmarks as agreed with the United Kingdom Government and established under the Fiscal Responsibility Act. The debt service to recurrent revenue ratio breached its target of 10% by 2.36 percentage points. The other two metrics the ratio of liquid assets to recurrent expenditure and the net debt to recurrent revenue ratio—were within the agreed benchmarks, surpassing them by 61.01 and 60.61 percentage points relative to their respective benchmarks of 25% and 80%.
