EX MIN 21/372 **CONFIRMATION OF THE MINUTES**

Hon Parliamentary Secretary for Economic Development, Hon Special Ministerial Assistant to the Hon Minister for Social Development/ Education and Financial Specialist remained.

Council confirmed the Minutes of the 66th Meeting of Executive Council held on Thursday 11th November, 2021 and the Special Meeting held on Wednesday 17th November, 2021.

Council noted H.E. the Governor's apologies for her absence at Council this week and that Mr Perin Bradley is Acting Governor.

MATTERS ARISING FROM THE MINUTES

Noted that engagement with the French authorities in relation to the commencement of day-trips to St Martin is ongoing.

In relation to certain matters raised in Ex Min 21/356, 21/357, 21/359 and 21/360 the guidance of the Attorney General's Chambers is awaited.

In relation to Ex Min 21/369 concerning the execution of the MOU with the Caribbean Medical Education Consulting Group, it is anticipated that the MOU will be signed shortly.

Epidemiology

Global overview

According to the WHO's most current epidemiological report of November 23, the global number of new cases continued to increase for the fourth week, a 6% increase compared to the previous week, with just over 3.6 million cases reported for the period November 15 – 21. This is largely attributed to a significant increase in new cases

in the European Region, with all other regions reporting declines or stable figures. The number of deaths increased (6%) as compared to the previous week, with just over 51,000 new deaths. There were significant increases in new deaths in the Western Pacific and the Region of the Americas.

The regions with the highest weekly incidence rates of cases and deaths per 100,000 population are the regions of the Americas and Europe. The US is the country with the highest number of reported cases in the last week, there were 558,538 new cases, which is a 3% decrease. As of November 21, there were over 256 million confirmed cases and over 5.1 million deaths have been recorded since the start of the pandemic.

Caribbean Region

The total number of confirmed cases is 2,140,715 in 35 countries/territories (including the 26 CARPHA Member States) and 442,665 in CARICOM Member States. The new total represents a 0.6% increase since the report on November 15. Some Member States continue to experience increasing positive case numbers. Cluster outbreaks through to community transmission of the virus, with increasing hospitalizations and deaths continues.

Anguilla

As of November 24, 2021, the total number of confirmed cases since the beginning of the pandemic in early 2020 is 1364 with 1246 recoveries, 3 deaths and 115 active cases. Among the active cases, two are imported. Eight persons are currently admitted to the Isolation Unit. The age range of the admitted patients is 35-85 years, there are six males and two females, five persons are unvaccinated, two persons are fully vaccinated and the status of one person is unknown.

The mode of infection for most cases is unknown, but the virus transmission within households continues to be evident.

Vaccination Deployment Update

Distribution

Since Monday 8th November, 1132 doses have been administered representing:

- 466 first doses
- 3 second doses
- 663 boosters

The breakdown by age for Pfizer first doses is as follows:

- 363 persons age 12-17
- 52 persons age 18 34
- 36 persons age 35 -4 9
- 10 persons age 50 64
- 5 persons age 65+

On Tuesday 23rd November, distribution began through the Welches Polyclinic, which will operate walk-in services until November 30. COVID-19 vaccination will then transition into regularly scheduled clinics on Thursdays and Fridays at both health centres.

Vaccine Uptake

As of November 24, 10,021 persons had received their first dose representing 80% of the initial target population figure of 12,600 persons (or 84% of the revised eligible estimate). Thus far, 9162 persons (72% of target) have received their second dose and 663 boosters have been administered. In a population estimate of 15,500 total persons, this would represent 65% of the population having received the first dose and 59% of the population having received two doses. The breakdown of first doses by age is as follows

- 363 persons age 12 17
- 3006 persons age 18 34
- 2874 persons age 35 49
- 2467 persons age 50 64
- 1309 persons age 65+

Vaccine Booster Eligibility

The Vaccination Deployment Team discussed streamlining booster eligibility criteria to align with the current UK Guidance, including expansion to persons over 40. Further, the team recommended expansion to certain essential services that work in close contact with the public, including uniform bodies (Police, Prison, Customs & Immigration, Fire & Rescue) and teachers.

COVID-19 Response Measures

The Ministry hired several personnel during the past two weeks to assist with telephone calls, reporting of results, issuing quarantine letters and contact tracing.

Council:

- 1) thanked the health team for their continued hard work;
- 2) noted the health teams observation that the outbreak in the prison is presently under control;
- 3) noted that information about where and how persons can obtain test results needs to be disseminated to the public;
- 4) agreed that the Ministry of Health and the Department of Natural Resources shall review the position as it relates to fishing in the waters to the south of Anguilla and present a recommendation to Council for consideration:
- 5) approved the health teams strategy to expand the priority groups for booster vaccinations, to include persons aged over 40, in accordance with UK guidance;
- 6) agreed to expand the priority groups for booster vaccinations to include uniform bodies (RAPF, Prison, Customs & Immigration, Fire & Rescue), teachers and parliamentarians. Persons with underlying health conditions e.g. hypertension,

diabetes, immunocompromised, lung and heart disease etc., healthcare workers and residents of elder care facilities are already within the priority group. Consider expanding the priority group to hospitality workers, noting that resources have to be managed to ensure the availability of vaccines for other persons within the priority group;

- approved the amendment of the regulations to add Sinovac/Sinopharm to the list of approved vaccines for entry into Anguilla, with immediate effect;
- 8) agreed that the fines for the importation of rapid tests should be removed, with immediate effect and that the health team shall work up guidance on the appropriate way in which to use these tests for public dissemination; and
- 9) reviewed the following existing COVID-19 related Regulations which expire on 30 November 2021, and approved amendment of the same to give effect to clauses 7, 8 and 9 above and extension of the following from 1 December 2021 to 15 January 2022:
 - a) Public Health (Quarantine)(COVID-19) Regulations;
 - b) Quarantine (COVID-19)(Arriving Passengers Health Clearance) Rules;
 - c) Public Health (Regulation of Ports) Regulations;
 - d) Public Health (Landing of Passengers)(Special Exemptions) Regulations;
 - e) Public Health (COVID-19 Monitoring of Approved Businesses) Regulations; and
 - f) Emergency (COVID-19 Border Control) Regulations

Hon Parliamentary Secretary for Economic Development, Hon Special Ministerial Assistant to the Hon Minister for Social Development/ Education and Financial Specialist remained.

The Select Anguilla Agency Act came into force on 3rd June 2019 and provided for the establishment of the Select Anguilla Agency, which is responsible for the administration of the economic residence programme. Section 5 of the Act provides for the establishment of a board to oversee the affairs of the Agency. In December 2020, the Select Anguilla Agency (Amendment) (No. 2) Act was passed. The Act removed and replaced the Ministry of Finance with the Ministry responsible for Economic Development and Investment. This change enables the Permanent Secretary for Economic Development or another Ministry representative to serve as a member and chairperson.

Council:

 approved the appointment of the Permanent Secretary, Economic Development, Investment, Commerce, Information Technology and Natural Resources as a member and chairperson of the board of the Select Anguilla Agency from November 25, 2021 to July 25, 2022.

EX MEM 21/233 FINANCIAL STOCKTAKE - AS AT OCTOBER 31, 2021

Council:

- 1) thanked the team for work well done;
- 2) noted the report on the financial position as at October 31, 2021, from the Budget Officer;

- noted that the CDB loan is pending and documentation is being prepared to take this forward;
- 4) noted that arrears total expenditure is \$39.1 million. Arrears of \$5.4 million and \$1.1 million are owed to two organisations respectively. Reducing arrears is an eligibility requirement by the CDB for the Policy Based Loan;
- 5) noted that utilities expenditures are under estimate and this should be reviewed;
- noted that in terms of quarterly financial reporting to the Ministry of Finance the compliance of the Statutory Bodies is poor;
- 7) noted that the reopening of the hospitality sector has had a positive affect on finances. Revenues need to be further increased so that the position with respect to deferred salaries and funding for social projects can be reviewed; and
- 8) the overall fiscal position remains challenging:
 - Overall financial position including debt amortization shows a surplus of EC\$19.91 million at the end of October;
 - Recurrent revenue was EC\$222.82 million this is EC\$1.30 million less than the original forecast. Overall percentage impact on recurrent revenue for the major revenue heads as a result of the COVID-19 pandemic are:
 - Property Tax positive 78.02%
 - Interim Stabilisation Levy positive 1.27%
 - Taxes on Goods and Services positive 14.18%
 - Excise Taxes negative 9.85%
 - Taxes on Specific Services positive 49.23%
 - Taxes on International Trade negative 7.95%
 - Sale of Goods and Services positive 26.33%
 - Recurrent expenditure was EC\$171.89 million which is EC\$7.22 million under estimate, although some electricity and

water bills whilst paid have not yet been recharged to expenditure;

- Capital balance shows a deficit of EC\$2.33 million. Capital Revenue remains at \$0 for the period whilst capital expenditure was EC\$2.33 million. Capital revenue from the EDF grant claim is budgeted at EC\$2.87 million the disbursal request has been submitted to the EU and is under review;
- Bank account balances stand at EC\$14.2 million;
- Central Government Debt inclusive of short term credit facilities moved from EC\$452.80 million at the end of 2020 to EC\$416.37 million at the end of October 2021. The reduction in debt is attributable to debt amortization payments of EC\$28.70 million, disbursements on the ACC Loan of EC\$0.84 million and exchange rate fluctuations of EC\$0.04 million;
- The Sinking Fund balance at the end of October 2021 is zero;
 and
- The next amortization payment of \$4.13 million, due for the fiscal year 2021 is payable in December.

Following discussion Council:

- agreed that Sheriton Development Inc. shall pay the Customs Administrative Cost of 5% as usual and there shall be no waiver of duty and tax on sandpaper, candles or pool tablets;
- 3) noted that the granting of the customs duty exemption (ICD) will result in foregoing approximately EC\$4,924,538.60 in revenues. The granting of interim goods tax (IGT) exemption will result in foregoing approximately \$3,948,134.31 in revenues. Noted that the estimated duty and tax loss to the Government is EC\$7,299,442.66;
- 4) agreed to bring forward the commencement date of the IGT and Excise Tax exemptions from January 1, 2022 to October 1, 2021, subject to confirmation that the tax compliance status of Shertion Development Inc. is satisfactory and that the entity is compliant with any arrangements that have been made in this regard;
- 5) approved the execution of an amendment to the MOU to include the agreed concession; and
- 6) approved the preparation of the required resolution by the Ministry for submission to the House of Assembly for consideration.

EX MEM 21/237 GOVERNMENT OF ANGUILLA CARICRIS CREDIT RATING REPORT 2021

The Hon Premier briefed Council. The Caribbean Information and Credit Rating Services Limited (CariCRIS) is the Caribbean's regional credit rating agency. It is a unique market-driven initiative aimed at fostering and supporting the development of regional debt markets in the Caribbean through, inter alia, the rating of Government and State Enterprises. A CariCRIS credit rating is an objective assessment of an entity's creditworthiness relative to other debt issuing entities and the CariCRIS regional scale rating compares all debt-issuing entities in a defined Caribbean region. As at September, 2021, CariCRIS has reaffirmed the assigned ratings of CariBBB+ (Foreign and Local Currency) on the regional rating scale to the notional debt of USD\$25 million of the Government of Anguilla.

These ratings include a 6-notch uplift for the high likelihood of support from the United Kingdom (UK). The notched-up regional scale ratings indicate that the level of creditworthiness of this obligation, adjudged in relation to other obligations in the Caribbean is adequate.

k) any breach of any of the conditions of this Licence shall result in all the estate and interest of the Licensee in the land being liable for forfeiture to the Crown.
