 - ii. specifying the other electoral district in relation to which his/ her name is listed on the quarterly list, and
 - iii. requiring the Electoral Registration Officer to delete his name from the other quarterly list;
- (d) Any qualified person whose name is spelt incorrectly on this quarterly list is required to give notice in **Form 10** to the Electoral Registration Officer at the Central Electoral Office on or before **May 23rd, 2024**;
- (e) any qualified person whose name appears on the existing register of voters, may give notice in **Form 8** to the Electoral Registration Officer at the Central Electoral Office on or before **May 23rd, 2023**, objecting to the inclusion on this quarterly list of any other person on the ground that that person is not a qualified person;
- (f) copies of the forms mentioned above may be obtained at the Central Electoral Office.
