EX MEMO 24/22 Approval of Amendments to The Special Economic Zone (SEZ) Legislation

Hon Parliamentary Secretary, Financial Adviser and Incoming Executive Council Clerk remained.

The Hon. Premier briefed Council. Ex Min 23/317 approved the proposal to amend the Special Economic Zone (SEZ) Act and Virtual City Regulations. During the amendment and consultation with the Financial Services Commission, it became apparent that further enhancements were necessary within the oversight framework of the Special Economic Zone Authority to ensure the effective functioning and regulatory integrity. Consequently, additional amendments are proposed and included in the Bill for the Special Economic Zone (Amendment) Act, 2024.

The amendment introduces Section 28A to the existing legislation, outlining the annual due diligence checks that the Authority must conduct for every special economic zone (SEZ) company. The amendment aims to enhance regulatory oversight by addressing significant changes that may affect the suitability of SEZ companies to operate.

Council approved the further amendments to:

- 1 Bill for the Special Economic Zone (Amendment) Act, 2024;
- 2 Special Economic Zone (Virtual City) (Extension of Geographical Designation) Regulations, 2024; and

3 Special Economic Zone (Virtual City) (Amendment) Regulations, 2024.

EX MEMO 24/24 Application to Host Raffle and Exemption from Public Lotteries Tax – Solarus Axa

Hon Parliamentary Secretary, Financial Adviser and Incoming Executive Council Clerk remained.

The Hon. Premier briefed Council. Solarus AXA is a commercial entity that sells solar systems and has engaged in several initiatives to help raise awareness of renewable energy. To further promote the initiative, Solarus AXA is requesting permission to host a raffle entitled "Go Green". The raffle is aimed at raising awareness about the benefits of renewable energy and also to provide practical incentives for individuals to adopt greener lifestyle choices. The applicant intends to sell 1500 tickets at US\$20 per ticket. The raffle is set to take place on April 04th, 2024.

Council:

- 1) noted that in respect of every lottery ticket sold, there is a duty charged at the rate of 10% of the price of the ticket. Raffle tickets are defined as lottery tickets;
- 2) noted that the grant of the requested tax exemption may result in a tax loss of up to EC\$8,064.60;
- 3) approved the application by Delroy Lake on behalf of Solarus AXA to host a raffle to assist the organization with its green initiative:
- 4) approved the waiver of the associated cost up to a revenue loss of EC\$8,064.60, and where such associated proceeds are donated to the Out Reach Pre-school; and

5) instructed the Ministry to prepare a Regulation for consideration by the House of Assembly in accordance with section 16 of the Financial Administration and Audit Act.
