The Minister of Finance briefed Council. Council noted that at the 100th meeting of the Eastern Caribbean Central Bank Monetary Council held on October 22, 2021, the Monetary Council approved an extension of the deadline for the ECAMC's acquisition of non-performing loans to July 20, 2023, and an amendment to Article 66 (1) of the ECAMC Agreement to permit Directors of the ECAMC to serve for a third term in accordance with Article 102 of the ECAMC Agreement

The amendment also seeks to extend the timelines for the final review of the corporation as provided for under Article 91, extending this review from the fifth anniversary of the Corporation to the eighth anniversary.

Ex Memo 23/219 Revised Analysis of Maximum Sale Price On Gasoline for Delta Petroleum (AXA) Ltd., Sol St. Lucia (Anguilla) Ltd. And Anguilla Gases Ltd

Parliamentary Secretary and Financial Specialist remained.

The Minister of Finance briefed Council. Pursuant to the Distribution and Price of Goods Act, R.S.A. c. D30 and the Distribution and Price of Goods (Maximum Gasoline Price Order) Regulations, 2022, the Minister responsible for Trade and Industry signed an Order, providing for the maximum price at which gasoline may be sold as of 28 June 2023. The maximum prices were:

- ✓ EC\$17.24 per imperial gallon for Sol St. Lucia (Anguilla) Ltd,
- ✓ EC\$16.06 per imperial gallon for Delta Petroleum (Anguilla) Ltd.,
- ✓ EC \$15.55 per imperial gallon for Anguilla Gases Ltd (regular);
 and
- ✓ EC\$16.84 per imperial gallon for Anguilla Gases Ltd. (premium).

International oil prices have risen in recent weeks as producers have tried to restrict output. An analysis of the current fuel import data and a reevaluation of the cost information was conducted on Sol St. Lucia (Anguilla) Ltd., Delta Petroleum (Anguilla) Ltd. and Anguilla Gases Ltd. to ensure that the price ceiling imposed was reasonable for both the consumers and fuel providers alike.

- 1. Approved the imposition of maximum price orders on the sale of gasoline, effective 4th September 2023 as follows:
 - ✓ EC\$18.67 per imperial gallon for Sol St Lucia (Anguilla) Ltd;
 - ✓ EC\$18.45 per imperial gallon for Delta Petroleum (Anguilla) Ltd:
 - ✓ EC\$17.04 per imperial gallon for Anguilla Gases Ltd. (regular).
 - ✓ EC\$18.45 per imperial gallon for Anguilla Gases Ltd. (premium).
- 2. Instructs that before the Order takes effect, fuel suppliers are to be notified of the proposed price order and allowed to provide any further pertinent information.
- 3. Instructs that a continuous review of the price orders be conducted as new information from the fuel suppliers and pertinent data on fuel import costs are obtained;

- 4. Instructs the Attorney General's Chambers to prepare the Orders and Notice of Extension of Regulations.
- Authorizes and instructs the Minister to sign and issue the Orders and Notices.
