# MATTERS ARISING FROM THE MINUTES

#### EX MIN 23/282

EX MEMO 23/228 Approval of an organizational structure to reintegrate the water services delivered by the Water Corporation of Anguilla into central government

Parliamentary Secretary, Financial Specialist and The Head of the Governor's Office remained.

The Hon Minister for MICUHT briefed Council. The Ministry proposes that a new organisational structure be adopted for the transition of the water services to central Government. This will enhance efficiency, adapt to technological advancements, promote sustainability in the operations, and better serve the water needs of Anguilla while complying with international, regional and national regulations. A phased approach will be adopted to implement the new organisational structure which is scheduled to start in January 2024.

# Council agreed that:

- 1. Continued work be done to perfect the proposed organizational structure (including a review of line management structures);
- 2. MICUHT to liaise with MOF to consider the required budgetary provisions for consideration alongside the new spending requests as part of the 2024 budget-setting process; and
- 3. Errors in the paper around salaries be addressed including positions for the Chief Water Engineer and other technical and skilled positions.

- (a) The Applicant be granted a waiver of the Government's Policy on requiring a 10% refundable deposit and waiver on the Aliens Land Holding Licence stamp duty, based on the grounds that the Applicant is adding his name to his mother's property who is Anguillian and also based on Mr. Liburd qualifying as a Caribbean national.
- (b) The Licensee shall fully comply with the laws of Anguilla enforced from time to time including the Land Development Control Act, the Property Tax Act, the Building Regulations, the Labour Relations Act 2018 and Work Permit Regulations, the Social Security Act, the Immigration and Passport Regulations and any statutory modification or re-enactment thereof and any rules or regulations made there under.

# EX MEMO 23/230 Anguilla Population and Housing Census, 2022 (AP&H Census 2022) – Update

Parliamentary Secretary, Financial Specialist and The Head of the Governor's Office remained.

The DG and Hon Minister for SIE briefed Council. PS, EDMSIE, Mrs Chanelle Petty-Barrett and Chief Statistician, Mrs Lori-Rae Alleyne-Franklin joined the meeting.

The Anguilla Statistics Department has been requested to provide a monthly update on the progress of the Anguilla Population and Housing Census 2022 enumeration phase.

The table below outlines the status as at 12 September 2023:

# Definitions:

Completed - all stages completed except validation. Near complete – between 1-20 households and the individuals therein to be completed.

The enumeration phase is approximately 65.9% complete, as at September 12, 2023 at 9:24am. If the rate of questionnaire completion remains consistent and enumerators are assigned to the outstanding EDs it is anticipated that 90% of the enumeration will completed by 31<sup>st</sup> December 2023. Executive Council may determine whether to end the enumeration at this stage or continue the enumeration process until 100% completion. The pros and cons of these approaches are as follows:
