#### **MATTERS ARISING FROM THE MINUTES**

#### EX MIN 23/336

### EX MEMO 23/269 Land for the Construction of a National Athletics Track

The Head of the Governor's Office remained

The Minister for Social Development & Education briefed Council. EX MIN 22/294 and EX MIN 22/372 refer. The Department of Planning undertook a comprehensive overview of possible locations centrally located for the development of a track and field facility on Anguilla. The review revealed six (6) possible locations for the development of a facility, namely:

- 1. Long Ground (3881B/69,70,71,72,73&74)
- 2. The Valley Bottom (58814B/63)
- 3. The Quarter- East of the High School (69014B/10)
- 4. The Quarter- West of the High School (68914B/261)
- 5. Tanglewood (78913B/375,382,21,377,379); and
- 6. Sandy Hill (69215B/34)

Based on the assessment Block 58814B Parcel 63 at Valley Bottom was deemed to be the most suitable for the development of a track and field facility. However, this plot of land is currently designated as Agricultural land.

Council noted that Project 10 would take a 4-phased approach. Phases 1, 3 and 4 are to be financed by the Government of Anguilla, while Phase 2 is to be covered under the project. The associated cost for the preparatory work to be done in Phase 1 can be borne from the budget for 2023, however, financing and completion dates for Phases 3 and 4 are to be determined at a later date subject to the applicable procurement procedure by the Government of Anguilla.

Council also noted the financial implications associated with the maintenance costs and the relocation of farmers.

#### Council:

1 Granted conditional approval to the designation of Block 58814B Parcel 63 from Agricultural land to land for the development of a National Athletics Track pending, the outcome of the bid to World Athletics.

- 2 Approved the submission of a planning application in relation to the development of a track and field facility on the said parcel.
- 3 Approved that the Government of Anguilla will enter into a Memorandum of Understanding with the Anguilla Amateur Athletic Federation (AAAF) for a minimum of ten (10) years for the construction of a fit-for-purpose national athletics track, once they have received notification that their application has been successful.

# EX MEMO 23/270 Sustainable Education Planning, Enhanced Monitoring and Management of the Education Sector

Education Planner, Mrs. Dawn Reid joined the meeting.

The Minister for Social Development & Education and the Education Planner briefed Council. EX MIN 21/67 also refers to the sustainable development of the Anguilla Education Management Information System (Anguilla EMIS) Project and accompanying E-Learning Platform that will support the work of the Education Planning Unit within the Ministry of Social Development and Education as it relates to the development and maintenance of statistical services in accordance with the Education and Training Statistics Framework and Policy.

Council noted the Ministry's intent to propose the establishment and filling of the posts of EMIS Systems Administrator and Projects Officer in the Education Planning Unit for the 2024 budget.

#### Council approved:

- 1. The continued establishment of the Anguilla EMIS and accompanying E-Learning Platform with:
  - a. The extension of the period of engagement of the Temporary EMIS Data Entry Clerk until June 30<sup>th</sup> 2024;
  - b. The Cloud Hosting of the Anguilla EMIS and E-Learning Platform;
  - c. Maintenance costs;

- d. The compensation of trainers to support the effective rollout of the Anguilla EMIS and E-Learning Platform;
- e. Curriculum content development and digitization
- Retention of the media services to support the content development and to ensure the inclusion of the local cultural context; and
- g. Integration of LJ Create into the LMS Platform to facilitate TVET Development.
- 2. The extension of the terms of engagement for the data entry clerk through the end of December 2023 which will be covered by the current budget allocation from the Ministry of Social Development and Education.

EX MEMO 23/271 Licences to use crown land in Island Harbour – Property situated in Registration Section East Central, Block 89418 B described as Parcel 1.

- 1. The granting of an occupational licence to Rudy Fleming to use Crown land in Island Harbour for property in Registration Section East Central, Block 89418 B, Parcel 1 (Part of) being 1,400sq.ft. as delineated on Survey Plan Ref. LS02-23.
- The terms of the licence are as follows:
  - a. Permission to use the premises for a specific purpose;
  - b. Fees per annum in the amount of EC\$4,516.18 (US\$1,680.00) are payable for the first year. Thereafter, the fee shall increase by Consumer Price Index (CPI) or two (2%) per cent per annum, whichever is greater for the remainder of the term:

- c. The government will reserve parking to be shared by patrons of the development and the general public;
- d. That development shall not be permanent;
- e. The development must operate within the laws of Anguilla including planning approval, licenses and taxes, and to the satisfaction of the Environmental Health Unit for sanitary purposes;
- f. Flexible termination clause to be included in the licence.
- 3. Attorney General's Chambers to draft the Licence to include the terms as set out for execution by Rudy Fleming and the Crown.
- 4. Ministry to prepare a policy paper for presentation and consideration as to what approach ought to be taken when dealing with Developmental areas.

- Full compliance with the terms and conditions as stipulated in the Memorandum of Understanding (MOU) held in escrow between Grace Capital Global Group, Inc. and the Government of Anguilla.
- 2. Submission of an Environmental Assessment Impact;
- 3. An updated Due Diligence Report;
- 4. Providing the Government of Anguilla with verifiable evidence of the source and immediate availability of funds to develop a five (5) star hotel and to build a marina;
