EX MIN 24/348 CONFIRMATION OF THE MINUTES

Hon. Parliamentary Secretary and Head of Governor's Office remained.

EX MEMO 24/255 2025 Statutory Body Budgets- Anguilla Financial Services Commission ("AFSC")

Hon. Parliamentary Secretary and Head of Governor's Office remained.

Council was presented with an outline of the AFSC's planned 2025 budget, which highlights the figures for inter alia, anticipated revenue, recurrent expenditure and capital expenditure. It was noted that the AFSC's 2025 budget is a combined budget that includes the Commission's regulatory activities as well as the Commercial Registry's operational and financial activities. The Commercial Registry was integrated into the AFSC on June 1, 2024. There are significant differences between the 2024 Approved Budget, Forecasted Outturn and the 2025 budget for the AFSC and this is due primarily to the Commercial Registry's revenue and expenditures being accounted for only a 7-month period in 2024. Whereas, the 2025 estimates encompass the full year's financial performance and projections for modest growth.

The 2025 budget of the AFSC notes:

- a. Anticipated Revenue of EC\$8.3M which is 46% higher than the 2024 approved budget and 65% higher than the forecast outturn. This increase is due to the expected increase in Registry Fees.
- b. Recurrent Expenditure of EC\$7.3M which represents a significant increase compared to the 2024 budget and actuals. This increase is driven by several factors including increased personnel costs associated with the Registry integration.
- c. Capital Expenditure is projected to be EC\$1M. This figure is inclusive of, inter alia, an update to the Commercial Registry Electronic System.

Executive Council:

- Noted and approved the planned 2025 Budget of the Anguilla Financial Services Commission, as outlined in the memorandum and presentation provided to Council; and
- Instructed the Anguilla Financial Services Commission to submit their quarterly reports to the Ministry of Finance no later than one month after the conclusion of each quarter to ensure compliance with statutory obligations.

EX MEMO 24/256 Application for Duty Exemption for New Anglia University Ltd.

Hon. Parliamentary Secretary and Head of Governor's Office.

Executive Council was briefed by the Honourable Premier and Minister of Finance on the application for duty-free concessions by New Anglia University Ltd. It was noted that New Anglia University Ltd's request for customs exemption aligns with the Customs Duty

Exemption Policy of 1998. Additionally, New Anglia University Ltd. and the Government of Anguilla have entered into a Memorandum of Understanding, under which the concessions for waiver of customs duties, as requested is to be granted. It was noted that the Customs Department has indicated that several of the items, including suture kits and books, requested for duty-free concessions, should not benefit from the concession. However, Executive Council noted that these items should benefit from the customs exemption, as they will be used directly to facilitate the medical education services provided by the applicant.

Executive Council approved the application for duty-free concessions by New Anglia University Ltd. for the total amount of all items listed in the Customs Duty Loss Calculation table submitted to Council.

EX MEMO 24/257 Cost of Living Support- Exemptions from Customs Duty and Tax for Essential Items

Hon. Parliamentary Secretary and Head of Governor's Office.

The Honourable Premier and Minister of Finance briefed Council on the proposed regulations. It was noted that in order to assist households in the purchase of essential items against the financial implications of external pressures, Council previously removed the duty and tax on these essential items to make them more affordable for lower-income consumers from April 2022 to December 31st 2024. It is proposed that this exemption in respect of the Import Customs Duty and Customs Administrative Costs Fee be extended until December 31st 2025 due to continuing inflationary pressures.

Executive Council:

- 1. Approved the extension of the current exemption on essential food items until 31st December 2025 for Import Customs Duty and administrative fees;
- 2. Approved the Customs (Exemption of Customs Duties on Food Items) Regulations, 2024 to give effect to same; and

3. Approved the Customs Administrative Costs Recovery (Exemption) Regulations, 2024.

The Honourable Minister of Home Affairs with responsibility for Constitutional Affairs briefed Council. The Elections Act stipulates the conduct and remuneration of Electoral Officers. Currently Electoral Officers are only paid for work done on Election Day Polls and not work done on Advanced Day Polls.

For work done on Election Day Polls electoral officers are paid:

a) Returning Officer: \$EC1125.00b) Presiding Officer: \$EC1050.00

c) Poll Clerk: \$EC600.00

It is proposed that Electoral officers be paid an additional 50% of Election Day Polls remuneration for work done on Advanced Day Polls.
