PUBLIC HOLIDAYS ACT, (R.S.A. c. P130)

SPECIAL PUBLIC HOLIDAY REGULATIONS, 2025

Regulations made by the Governor, with the advice of the Executive Council, under section 4 of the Public Holidays Act, R.S.A. c. P130.

Interpretation

1. In these Regulations—

“Act” means the Public Holidays Act, R.S.A. c. P130.


Appointment of a special public holiday

2. The 28th day of February 2025 is hereby declared and appointed as a special public holiday throughout Anguilla and is a public holiday for all purposes of the Act.

Citation

3. These Regulations may be cited as the Special Public Holiday Regulations, 2025.
