# EX MEMO 25/81 Waiver of Duty and Tax on Imports Associated with the Anguilla Summer Festival

Senior Ministerial Advisor for Health and Ministerial Assistant for Sports, Youth & Culture remained.

The Honourable Premier briefed Council. Persons participating in ASF events usually have to import items associated with their participation, such as, costumes and equipment. The Department of Youth and Culture has been consulted on the persons and types of items anticipated to be imported. Provisions exist under the Conditional Exemptions under the Integrated Customs Tariff (Amendment) (No. 2) Regulations, 2022 for such a waiver.

#### Council:

- 1. Considered and approved an overarching exemption from duty and tax for the Anguilla Summer Festival in the following specified areas in accordance with the Conditional Exemptions, subject to the following criteria:
  - Persons must fall within the proposed groupings, and items to be imported duty and tax-free will be restricted as follows:
    - a) Pageant Contestants: Male and Female Formal Wear, Costumes, Accessories and Shoes
    - b) Persons in organized Troupes-Costumes and Accessories
    - c) Bands- Temporary Imports of Trailers and Sound Systems
    - d) Fringe Events- Promotional Items
  - ii. Persons must bear a letter of support from the Department of Youth and Culture confirming their participation in the event and confirming that the items are associated with such participation related to not-

for-profit cultural activities. Department of Youth and Culture support must not extend beyond the specified classes of persons and associated items.

iii. The period for clearing imports should be limited until 31<sup>st</sup> August 2025.

# EX MEMO 25/82 Waiver of Temporary Food Premises Permit for the Annual Welches Village Fest

Senior Ministerial Advisor for Health and Ministerial Assistant for Sports, Youth & Culture remained.

The Honourbale Premier briefed Council. The annual Welches Village Fest is set to take place on Monday, 9<sup>th</sup> June 2025. The food vendors for the annual Welches Village Fest have requested a waiver of the fees for the Temporary Premises Permit to allow them to operate on that day. A historical precedent exists where exemptions are granted to participants in such festivities. As such, it is proposed that the fees for Temporary Food Premises Permits for that day be granted in accordance with Section 16 of the Financial Administration and Audit Act R.S.A. Ch. F027.

Executive Council considered and approved the proposed waiver from Temporary Food Premises Permit associated with the annual Welches Village Fest which is to take place on 9<sup>th</sup> June 2025.

Thereafter, forfeiture proceedings for the property will be commenced by the Government of Anguilla for a period of twenty-four (24) months.

- (b) The property must be used for tourism purposes.
- (c) That the development complies with Planning Ref: 24/0369 for the construction of Villas comprised of 14 units.
- (d) Parcel 91 to be amalgamated with Parcel 92 within three (3) months of the issue of the licence.
- (e) The Applicant shall, during the period of construction, permit the authorised officers or agents of the Government of Anguilla access to the land to inspect the site and building work.
- (f) The express condition in the Licence that the development shall be completed within forty-eight (48) months, failing which a penalty of US\$3,500.00 shall apply for each calendar month or part thereof that the project remains uncompleted without reasonable justification for the delay in completion. The said penalty shall continue for a period of 12 months. Thereafter, forfeiture proceedings for the property will be commenced by the Government of Anguilla.
- (g) The Applicant is exempted from Government's Policy on restricting Aliens from holding no more than half an acre on the grounds that the intent purchaser is developing a tourism product that would yield financial revenue for the Government through rentals.

(h) The Licensee shall fully comply with the laws of Anguilla in force from time to time including the Land Development Control Act, the Property Tax Act, the Building Regulations, the Labour Relations Act 2018 and Work Permit Regulations 2023, the Social Security Act, the Immigration and Passport Regulations and any statutory modification or re-enactment thereof and any rules or regulations made there under.
