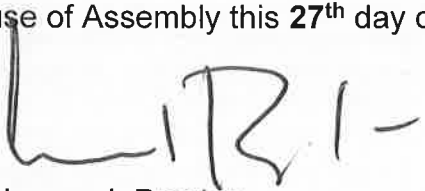
RESOLUTION

FINANCIAL ADMINISTRATION AND AUDIT ACT, (R.S.A. C. F27)
FINANCIAL ADMINISTRATION AND AUDIT (REMISSION) (CAPITAL ONE AND NEW YORK TIMES VIDEO SHOOT) REGULATIONS, 2024

Regulations made by the Governor in Council under section 16 of the Financial Administration and Audit Act, R.S.A. c. F27.

WHEREAS, the Customs Department is responsible for collecting Customs Duty, Customs Service Fee and Goods and Service Tax at the port in relation to the importation of goods pursuant to the Customs Act, R.S.A. c. C169, the Customs Service Fee Act, R.S.A. c. C195 and the Goods and Services Tax, R.S.A. c. G12 respectively;

WHEREAS, on the temporary importation of goods the Customs Department levies a Custom Service Fee charge of 1%;

WHEREAS the Governor in Council may make regulations to remit all or part of any tax, fees or other amounts that is imposed, or authorised to be imposed, under the Financial Administration and Audit Act, R.S.A. c. F27 or any other Act where the Governor is satisfied that it is in the public interest to do so;

WHEREAS the New York Times is one of the world's most influential newspapers, that covers local, national and international news along with opinion pieces, investigative journalism and reviews and Capital One Financial Corporation is a major U.S. bank holding company that specializes in credit cards, banking and savings accounts *inter alia*;

WHEREAS the New York Times and Capital One will be collaborating to develop a series of 3-4 minute travel videos highlighting authentic and unforgettable experiences in popular destinations such as Anguilla and as such require the temporary importation of equipment to facilitate said video shoot;

WHEREAS this collaborative video shoot between New York Times and Capital One offers potential significant marketing exposure to Anguilla as a tourism destination, thereby promoting Anguilla's main industry, it is in the public interest to facilitate this video shoot;

WHEREAS the Minister responsible for Finance has taken the decision that the collection of a Customs Service Fee on the importation of equipment for the proposed video shoot specified in the Schedule during a specified period should be remitted;

WHEREAS the Governor in Council is satisfied that it is in the public interest to remit the Customs Service Fee at the port in relation to the importation of equipment to facilitate the video shoot;

WHEREAS the remission of tax, fees or other amounts owed to the Crown may be conditional or unconditional;

AND WHEREAS the Governor in Council agrees to remit the Customs Service Fee at the port in relation to the temporary importation of equipment to facilitate said video shoot;

NOW THEREFORE, the Governor in Council makes the following Regulations—

Interpretation

1. In these Regulations—

“specified period” means 18 August, 2024 to 21 August 2024.

Remission of Custom Service Fee on temporary importation of equipment

2. The Customs Service Fee due and payable on the temporary importation of equipment for the New York Times and Capital One video shoot listed in the Schedule are hereby remitted.

Conditions for remission

3. (1) Remission referred to in section 2 shall only be granted where the equipment listed in the Schedule is imported during the specified period.

(2) The equipment shall be exported before on or before 21 August 2024.

(3) Where a person fails to comply with subsections (1) and (2) he shall be required to pay the Customs Service Fee remitted pursuant to section 2.

Citation

4. These Regulations may be cited as the Financial Administration and Audit (Remission) (Capital One and New York Times Video Shoot) Regulations, 2024.

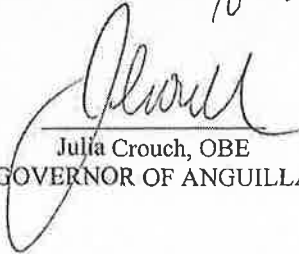
