# COMMERCIAL REGISTRY AND BENEFICIAL OWNERSHIP REGISTRATION SYSTEM (AMENDMENT) ACT, 2023

[Gazette Date: , 2023] [Commencement: Assent under section 57 of the Constitution]

An Act to amend the Commercial Registry and Beneficial Ownership Registration System Act, 2022.

Enacted by the Legislature of Anguilla

#### PART 1

#### **GENERAL PROVISIONS**

#### **Interpretation**

1. In this Act, "Act" means the Commercial Registry and Beneficial Ownership Registration System Act, 2022.

#### Amendment of section 14

- 2. The Act is amended by deleting subsection (4) and substituting the following—
  - "(4) For the avoidance of doubt, and without limiting subsection (1), this section applies to a trust or corporate services provider when acting as the registered agent of an Anguilla company, a limited partnership or an Anguilla Foundation.".

#### **Amendment of section 19**

- **3.** The Act is amended in section 19(1)
  - (a) in paragraph (b), by deleting "and" after the semi colon; and
  - (b) by deleting paragraph (c) and substituting the following—
    - "(c) make a written record of—

- (i) the identity of each beneficial owner of the company; and
- (ii) the prescribed beneficial ownership information it obtains for each registrable person; and"; and
- (d) retain any written record made under paragraph (c) for a period of 6 years after the person concerned ceases to be a beneficial owner or registrable person.".

#### Amendment of section 28

- **4.** The Act is amended in section 28(2)—
  - (a) by deleting paragraph (b) and substituting the following—
    - "(b) if the registrable person is an Anguilla company or a foreign listed company—
      - (i) its full name;
      - (ii) in the case of an Anguilla company, its company number or, in the case of a foreign listed company, its registration number, if applicable;
      - (iii) in the case of an Anguilla company, its registered office or, in the case of a foreign listed company, its registered office or equivalent;
      - (iv) in the case of a foreign listed company, the country of its incorporation, formation or constitution;
      - (v) the legal form of the Anguilla company or foreign listed company and the law under which it is incorporated, formed or otherwise constituted;
      - (vi) the nature of the company's beneficial ownership of the Anguilla company;
      - (vii) in the case of a listed company or a foreign listed company, the exchange on which the company's shares are listed; and
      - (viii) such other information as may be prescribed;"; and
  - (b) in paragraph (c)(iv)(A), by deleting "or a foreign listed company".

#### **Insertion of section 42A**

5. The Act is amended by inserting the following section in Part 5, after section 42—

#### "Destruction of documents

**42A.** The Registrar may destroy any document kept by the Registrar where it relates to a company that has been dissolved for 20 years or more if the Registrar is of the opinion that it is not necessary for the document to be retained.".

#### **Insertion of section 44A**

**6.** The Act is amended by inserting the following section in Part 5, after section 42—

## "Immunity

- **44A.** No liability attaches to the Registrar or to any person acting under the authority of the Registrar—
  - (a) for anything done, or omitted to be done, in good faith, in the discharge or purported discharge of the functions or duties of the Registrar under this Act; or
  - (b) without limiting paragraph (a), for any loss or damage caused wholly or partly by reason of any error or omission that has arisen as a result of any failure of or defect, breakdown or malfunction in the registration system.".

#### Amendment of section 50

7. The Act is amended section 50(2)(b)(iii), by deleting "protected cell companies" and substituting "segregated portfolio companies".

## Repeal of Companies Registry Act

**8.** The Companies Registry Act (Cap. C70) is repealed.

#### Citation

**9.** This Act may be cited as the Commercial Registry and Beneficial Ownership Registration System (Amendment) Act, 2023.
