An Act to amend the Commercial Registry and Beneficial Ownership Registration System Act, 2022.

## Enacted by the Legislature of Anguilla

### Interpretation

**1.** In this Act, "principal Act" means the Commercial Registry and Beneficial Ownership Registration System Act, 2022.

#### Insertion of new section 8A

2. The principal Act is amended by inserting the following new section after section 8—

#### "Access to the registration system by the Competent Authority

**8A.** (1) The Registrar must ensure that, at all times, the Competent Authority has direct and immediate access to the Beneficial Ownership Register and the Commercial Registry, including the information recorded and the documents stored in each.

(2) The Competent Authority may access the Beneficial Ownership Register and the Commercial Registry only to the extent necessary to discharge its functions or to exercise its powers.

(3) The functions and powers of the Competent Authority include the Competent Authority's functions and powers under—

(a) this Act;

- (b) the Tax Information Exchange (International Co-operation) Act; and
- (c) any other related enactment.

(4) For the purposes of this section "Competent Authority" has the meaning given in the Tax Information (International Cooperation) Act 2016.

- (a) in subsection (2)(a) by deleting the phrase "28(1)(b)" and substituting the phrase "28(1)(c)"; and
- (b) in subsection (2)(b) by deleting the phrase "28(1)(c)" and substituting the phrase "28(1)(d)".
