EMERGENCY POWERS (COVID-19 BORDER CONTROL) (AMENDMENT) (NO. 8) REGULATIONS, 2020

Regulations made by the Governor under section 4 of the Emergency Powers Act, R.S.A. c. E45

Interpretation

1. In these Regulations, principal Regulations means the Emergency Powers (Covid-19 Border Control) Regulations, 2020 (R.A.11/2020).

Amendment of section 1

2. The principal Regulations is amended in section 1 by deleting the definition of "specified period" and substituting it with the following—

"specified period" means the period from 1 November 2020 to 12 December 2020.

Amendment of section 3

- 3. The principal Regulations is amended in section 3(2) by inserting the following new paragraph after paragraph (d)—
 - "(e) passenger boats that comply with section 3A".

Insertion of new section 3A

4. The principal Regulations is amended by inserting the following new section after section 3—

"Passenger Boats

- 3A. (1) The owner or boat captain of a passenger boat that wishes to operate in a ferry schedule between Anguilla and St. Maarten/St Martin as approved by the Anguilla Air and Sea Ports Authority shall apply to the Commissioner of Police for permission to operate in the Schedule.
- (2) Where permission to operate in the ferry schedule is granted under this section, the passenger boat shall not operate in Anguilla waters unless it is operating in the ferry schedule specified in subsection (1).
- (3) Where a passenger boat wishes to operate outside the ferry schedule, the owner or boat captain of the passenger boat shall obtain written permission from the Commissioner of Police on each occasion where the boat operates outside the schedule.
- (4) Where a passenger boat is found to be operating in breach of this section, the boat owner or captain commits an offence.

Citation and commencement

5. These Regulations may be cited as the Emergency Powers (COVID-19 Border Control) (Amendment) (No. 8) Regulations, 2020 and shall come into force on 1 November, 2020.
