## APPOINTMENT AS COMMISSIONER OF POLICE IN ANGUILLA

TO: Mr. DAVID LYNCH

### **GREETINGS**

WHEREAS it is provided in section 77 of the Constitution of Anguilla, contained in the Schedule to the Anguilla Constitution Order (1982), that the Governor, in Her Majesty's name and on Her behalf, may constitute such offices for Anguilla as may lawfully be constituted by Her Majesty and, subject to the provisions of any law in force in Anguilla, may make appointments (including appointments on promotion and transfer) to any such office; and any person so appointed shall, unless it is otherwise provided by any such law, hold office during Her Majesty's pleasure.

**AND WHEREAS** section 6 of the Anguilla Police Act R.S.A c. A70 provides that there shall be a Commissioner of Police who shall have the command and superintendence of the Force and shall be responsible to the Governor for the efficient administration and government of the Force and for the proper expenditure of all public money appropriated for the service thereof.

**AND WHEREAS** it is provided in section 7(1) and (2) of the Anguilla Police Act aforesaid that the Commissioner of Police shall be appointed by the Governor acting in his discretion and every appointment to the Force shall be made by the Governor after consultation with the Public Service Commission.

**NOW THEREFORE**, by virtue and in exercise of the powers vested in me by section 77 of the Constitution of Anguilla aforesaid, and in pursuance of the provisions of section 7 (1) and (2) of the Anguilla Police Act, and all other powers thereunto enabling me, acting after consultation with the Public Service Commission, **I, DILEENI DANIEL-SELVARATNAM**, Governor of Anguilla, do hereby appoint you DAVID LYNCH as Commissioner of the Royal Anguilla Police Force with all powers, duties and privileges appurtenant to that office with effect from the  $| ^{\circ} |$  day of February, 2021.

#### PUBLIC HEALTH ACT, R.S.A. C. P125.

# PUBLIC HEALTH (TEMPORARY RESTRICTIONS ON MOVEMENT OF PEOPLE AND PUBLIC GATHERINGS) REGULATIONS, 2021

Regulations made by the Minister with approval of Executive Council under section 8 of the Public Health Act, R.S.A. c. P125.

WHEREAS the disease known as coronavirus (COVID-19) has been declared a global pandemic which threatens the public health and safety of many territories and states around the globe resulting in widespread infection of persons and resultant deaths of many;

AND WHEREAS the rate of infection and territorial spread of the COVID-19 disease has been confirmed to now be present in the territory;

AND WHEREAS under and by virtue of the Public Health Act R.S.A. c. P125, the Minister responsible for health is empowered to take necessary measures to protect and preserve the public health and safety of the people of Anguilla from any infectious or notifiable disease;

AND WHEREAS in consequence of the global spread of the infectious disease known as COVID-19 it has become necessary for the Minister to take certain measures;

AND WHEREAS section 2 of the Public Health Act R.S.A. c. P125 provides that the duties, powers and functions of the Minister shall extend to and include all matters relating to promotion or preservation of the health of the people of Anguilla;

AND WHEREAS section 3(c) of the aforesaid Act provides that in the exercise of his duties, powers and functions under section 2 of the Act the Minister shall have power to make such orders and issue such directions as he deems advisable for the abatement of any nuisance or the removal of any condition which, in his opinion, is or may become injurious to the public health or in respect of any other matter that, in his opinion, is necessary for the purpose of this Act;

AND WHEREAS section 8 of the said Act provides that the Minister may, with the approval of the Executive Council, make regulations for the proper execution and carrying out of the purposes and provisions of the Act generally and in particular with respect to certain specified matters;

NOW THEREFORE, by virtue and in the exercise of the powers vested in me by sections 2 and 8 of the Public Health Act, I, Dr. Ellis Lorenzo Webster, Minister of Health, by and with the approval of the Executive Council, hereby make the Regulations which shall now follow:

#### Interpretation

1. In these Regulations—

"licensed premises" has the same meaning as in the Liquor Licences Act R.S.A. c. L75;1

"specified period" means 22 April 2021 to 6 May 2021;

<sup>&</sup>lt;sup>1</sup> "licensed premises" means the room, house, building or place in respect of which a licence shall have been issued to sell liquor therein by retail and, for the purposes of this Act, shall include any premises with respect to which a beer licence or a restaurant licence shall be issued.

#### Restrictions on movement of persons

- 2. (1) Every person shall remain confined to their place of residence, inclusive of their outdoor space, during the specified period.
  - (2) Subsection (1) does not apply to—
    - (a) persons working in the following establishments—
      - (i) health care facilities, pharmacies, residential care facilities and suppliers of oxygen,
      - (ii) the Royal Anguilla Police Force and Anguilla Fire and Rescue Services,
      - (iii) Her Majesty's Prison and the Zenaida Haven Residential Centre,
      - (iv) Government offices, including the judiciary,
      - (v) government agencies,
      - (vi) the House of Assembly,
      - (vii) grocery stores or wholesale food and drink suppliers,
      - (viii) restaurants and bakeries,
      - (ix) gas stations,
      - (x) water, electricity and telecommunication companies,
      - (xi) waste disposal and sanitation companies,
      - (xii) companies offering electronic communication services, including print and electronic media,
      - (xiii) commercial banks, credit unions or money services businesses,
      - (xiv) shipping and brokerage companies,
      - (xv) radio stations,
      - (xvi) mortuaries,
      - (xvii) security companies,
      - (xviii) construction and hardware companies;
      - (xix) automotive repair and supply companies, and
    - (b) persons attending company meetings.
- (3) Notwithstanding subsection (1), a person may leave their place of residence for the purpose of—
  - (a) essential visits to a grocery store, a wholesale food and drink supplier, a restaurant, a commercial bank, a credit union, a money services business or a gas station;

- (b) essential visits to a doctor, pharmacy or other health care provider for the purpose of receiving medical care including vaccinations;
- (c) outdoor exercise for periods not exceeding an hour and a half per day between the hours of 5:00 a.m. to 6:00 p.m.; and
- (d) attending a funeral or a wedding in accordance with section 5(3).

#### Physical distancing requirements

- 3. Every establishment permitted to operate under section 2 shall—
  - (a) endeavour to facilitate physical distancing of no less than 3 feet between persons inside the establishment;
  - (b) determine the number of persons that may be permitted in any establishment at any one time by permitting one person for every 30 square feet of floor space; and
  - (c) within 24 hours of the commencement of these Regulations, place distance markers 3 feet apart on the floor space of such establishments, indicating where customers must stand while waiting inside the establishment.

#### Wearing of masks compulsory

**4.** Where a person is permitted to leave their place of residence pursuant to section 2, he shall wear a mask at all times.

#### Prohibition on public gatherings

- 5. (1) Where a person is permitted to leave their place of residence pursuant to section 2, such persons shall at all times, endeavour to remain 3 feet away from any other person.
- (2) Where a person is permitted to leave their place of residence pursuant to section 2(3)(a),(b) and (c) such persons are prohibited from assembling in groups exceeding 5 persons in any public place during the specified period.
- (3) Notwithstanding subsection (2), the maximum number of persons permitted to assemble for the purpose of a funeral or a wedding is 12 persons.
- (4) For the avoidance of doubt, subsection (2) does not prohibit the assembly, for work purposes, of persons referred to in section 2(2).

#### Prohibition of restaurant sit-down services

- 6. (1) No restaurant shall offer sit-down services during the specified period.
- (2) For the avoidance of doubt, restaurants are only permitted to offer take-out services during the specified period.
- (3) No restaurant shall allow the congregation of more than 5 persons at the restaurant at any particular time.

#### Closure of licensed premises

- 7. (1) Licensed premises shall be closed during the specified period.
- (2) Subsection (1) does not apply to grocery stores or wholesale food and drink suppliers which have been licensed to sell liquor by retail or wholesale.

#### Closure of schools, places of worship and day care facilities

- 8. The following places shall be closed during the specified period—
  - (a) schools, public and private;
  - (b) places of worship and religious instruction; and
  - (c) day care facilities.

#### Restriction of visitors at residential homes, hospitals and prison

- 9. No person is permitted to visit persons housed at the following places during the specified period—
  - (a) The Princess Alexandra Hospital;
  - (b) Her Majesty's Prison;
  - (c) The Zenaida Haven Residential Centre; and
  - (d) Residential homes or other medical or care home facilities.

#### Restriction on social activities

- 10. For the avoidance of doubt—
  - (a) no person shall—
    - (i) host a private party which includes any person not living in the household, or
    - (ii) attend a private party not held in their household.
  - (b) no person shall host or attend—
    - (i) a recreational or competitive sporting event,
    - (ii) a banquet, ball or reception,
    - (iii) a meeting of a fraternal society, private or social club or civic association or organisation,
    - (iv) a funeral, exceeding 12 persons including 1 officiant and essential mortuary staff,
    - (v) a wedding, comprising more than 12 persons including the bride, the bridegroom, the official witnesses and the marriage officiant, or
    - (vi) any other social event.

#### Offence

11. Any person who fails or neglects to carry out or infringes any provisions of these regulations, is guilty of an offence and is liable upon summary conviction to a fine of \$2,500 or to imprisonment for a term of 6 months or to both.

#### Citation and commencement

12. These Regulations may be cited as the Public Health (Temporary Restriction on Movement of People and Public Gatherings) Regulations, 2021 and shall come into force on 22 April 2021.

# PUBLIC HEALTH (COVID-19 MONITORING OF APPROVED BUSINESSES) (AMENDMENT) (NO 4) REGULATIONS, 2021

Regulations made by the Minister with approval of Executive Council under section 8 of the Public Health Act, R.S.A. c. P125.

#### Interpretation

1. In these Regulations, the principal Regulations means Public Health (COVID-19 Monitoring of Approved Businesses) Regulations, 2020 (R.A. 94/2020).

#### Amendment of Section 1

2. Section 1 of the principal Regulations is amended by deleting the definition of "specified period" and substituting it with the following—

""specified period" means 18 April 2021 to 6 May 2021".

#### Citation

3. These Regulations may be cited as the Public Health (COVID-19 Monitoring of Approved Businesses) (Amendment) (No 4) Regulations, 2021.

# PUBLIC HEALTH (COVID-19 REGULATION OF PORTS) (AMENDMENT) (NO. 4) REGULATIONS, 2021

Regulations made by the Minister with approval of Executive Council under section 8 of the Public Health Act, R.S.A. c. P125.

#### Interpretation

1. In these Regulations, the principal Regulations means Public Health (COVID-19 Regulation of Ports) Regulations, 2020 (R.A. 93/2020).

#### Amendment of section 1

2. Section 1 of the principal Regulations is amended by deleting the definition of "specified period" and substituting it with the following—

""specified period" means 18 April 2021 to 6 May 2021".

#### Amendment of section 2

- 3. Section 2 of the principal Regulations is amended by—
  - (a) deleting subsection (1) and substituting it with the following—
    - "(1) The entry or departure by aircraft, ships, vessels, or boats to or from any place in Anguilla is prohibited until 6 May 2021."; and
  - (b) inserting the following new paragraph immediately after paragraph (c)—
    - "(ca) aircrafts, ships, vessels or boats used for the repatriation of-
      - (i) Anguilla citizens sent overseas by the Health Authority of Anguilla to seek medical treatment; and
      - (ii) any persons who accompanied the citizens referred to in sub-paragraph (i).

#### Citation

4. These Regulations may be cited as the Public Health (COVID-19 Regulation of Ports) (Amendment) (No. 4) Regulations, 2021.

QUARANTINE ACT, R.S.A. C. Q5

# QUARANTINE (COVID-19) (ARRIVING PASSENGERS HEALTH CLEARANCE) (AMENDMENT) (NO. 5) RULES, 2021

Rules made by the Quarantine Authority and approved by the Governor in Council under section 5(2)(c) of the Quarantine Act, (R.S.A. c. Q5).

WHEREAS the disease known as coronavirus (Covid-19) threatens the public health and safety of many territories and states around the globe resulting in widespread infection of persons and resultant deaths of many;

AND WHEREAS under and by virtue of the Public Health Act R.S.A. c. P125, the Minister responsible for health is empowered to take necessary measures to protect and preserve the public health and safety of the people of Anguilla from any infectious or notifiable disease;

AND WHEREAS the Minister has exercised such powers pursuant to section 8 of the Public Health Act by enacting Public Health (COVID-19 Regulation of Ports) Regulations, 2020 (R.A. 93/2020);

AND WHEREAS section 2 of the aforementioned Regulations provides that for the purpose of preventing or controlling the spread of the Covid-19 disease, the entry or departure by aircraft, ships, vessels or boats to or from any place in Anguilla is regulated until 6 May 2021;

AND Whereas section 2 of the Public Health (COVID-19 Regulation of Ports) Regulations 2020 (R.A. 93/2020) allows for the entry into Anguilla of aircrafts, ships, vessels or boats used for the repatriation of Anguillan citizens to Anguilla;

AND WHEREAS the Government has reopened its ports to permit entry into Anguilla of pre-approved visitors;

AND WHEREAS section 5 of the Quarantine Act provides that the Quarantine Authority may make rules for the governance of places where persons or things are detained or taken for examination and of places used for the observation or isolation of persons;

AND WHEREAS the Chief Medical Officer has been appointed as the Quarantine Authority pursuant to the section 3 of the Quarantine Act;

NOW THEREFORE, by virtue and in the exercise of the powers vested in me by section 5 of the Quarantine Act, I, DR. AISHA ANREWIN, Chief Medical Officer, by and with the approval of the Governor in Council, hereby make the Rules which shall now follow—

#### Interpretation

1. In these Rules the principal Rules means the Quarantine (COVID-19) (Arriving Passengers Health Clearance) Rules, 2020.

#### Amendment of section 15

2. The principal Rules are amended in section 15 by deleting the phrase "30 April 2021" and substituting the phrase "6 May 2021".

#### Citation

3. These Rules may be cited as the Quarantine (COVID-19) (Arriving Passengers Health Clearance (Amendment) (No. 5) Rules, 2021.
