- (i) the GOA would **not** extend the reduced 2.5% admin fee into the operational phase (June 2020). This is not the practice. The project already had duty free concessions for periodic refurbishing;
- (ii) the GOA would <u>not</u> extend the concessions on ALHL and RRAL to 2020. The quantum of the concessions far exceeds the value of the funding for the road;
- (iii) the Attorney General's Chambers be charged with assessing and advising on the draft third addendum to the MOU;
- (iv) recognising that the construction of the road was a separate matter from the MoU, the GoA would be willing to make a contribution of EC\$240,000.00 towards the road construction (comprised of EC\$65,000.00 for marl for sub-base; EC\$25,000.00 for thermoplastic line marking; and EC\$150,000.00 for engineering and technical assistance); and
- (v) the newly constructed road be renamed the Zemi Beach Way in recognition of the fact that the developer had agreed to undertake and finance a major re-development of the road way.
