Council noted that two Basic Grade Officers had recently tendered their resignation effective 11th and 20th December 2013 respectively. Council agreed that the vacant posts should be filled.

Council suggested that due to the frequent turnover of Prison Officers, creation of a pool process should be set up with Public Administration and MSD, similar to that done for vacancies at Zenaida Haven.

EX MIN 13/692 EX MEM 13/316 APPROVAL TO REVISE IMMIGRATION AND CUSTOMS FORM

PS, EDICT remained for discussion.

Council:

- (i) approved the revised combined form;
- (ii) agreed that the Attorney General's Chambers be tasked with revising the "1994 Anguilla Conditional Exemptions" list. In particular Section 11 (c) would have to be amended to reflect the following:-

Belongers of Anguilla and returning residents in relation to used personal effects and baggage and where such persons have been abroad for more than 72 hours, also purchases and gifts to the value of EC\$150 for each adult and EC\$75 for each child under 18 years.

Section 11 (d) will have to be amended to reflect the following:

Visitors in relation to personal effects and baggage compatible with intended length of stay, where they intend to stay for less than 6 months.

Section 11 (f) will have to be amended to reflect the following:

Passengers over the age of 18 are entitled to import free of duty 200 Cigarettes; or 50 Cigars; or 1/2 lb. or 230g of Tobacco; 1 litre or 40 oz. of Spirits; 1 litre or 40oz of Wine; 170ml or 6 oz. of Perfumed Spirits; and 340ml or 12 oz. of Eau de toilette.

(iii) agreed that the form becomes effective as soon as practicable thereafter.

Council commended the team who worked diligently to accomplish this.

EX MEM 13/317 VESTING OF CROWN LANDS TO THE ANGUILLA AIR AND SEAPORT AUTHORITY – CLAYTON J LLOYD INTERNATIONAL AIRPORT, BLOWING POINT, ROAD BAY AND CORITO SEAPORTS

Council agreed:

- (i) the Government of Anguilla should vest all ports lands to the Anguilla Air & Sea Ports Authority in accordance with the "Act" in a leasehold interest;
- (ii) the lands to be vested to the AASPA are as follows:
 - a) the Clayton J Lloyd International Airport, as delineated on Survey Plan LS19-13, subject to:
 - 1. the amalgamation of Crown lands as described in Appendix 3 (attached);
 - 2. the transfer of land in Registration Section South Central 38713B Parcel 257, Parcel 25 (part of), Parcel 59 and Parcel 88 (part of);
 - 3. a revised schedule should be drafted by the Attorney General's Chambers and gazetted by MICUH;
 - b) seaport of Road Bay as delineated on Survey Plan LS51-09, described in schedule 1 Part 2 of the Act;
 - c) seaport of Blowing Point as delineated on Survey Plan LS20-13, subject to:
 - a revised schedule being drafted by the Attorney General's Chambers and gazetted by MICUH; and
 - d) seaport of Corito as delineated on Survey Plan LS49-09, described in schedule 1 Part 4 of the Act.

EX MEM 13/319 MORATORIUM ON THE ESTABLISHMENT OF BUSINESSES ON ANGUILLA AND AMENDMENT TO THE TRADES, BUSINESSES, OCCUPATIONS AND PROFESSIONS LICENSING ACT

Council considered EX MEM 13/319 which sought approval to impose a one year moratorium on the granting of business licenses for the establishment of bars, beauty salons, retail and wholesale businesses of consumables, and restaurants other than those in hotels.

The Hon Attorney General noted that amendments to the Trades, Businesses, Occupations and Professions Licensing Act would be required to give effect to this policy intent. HE The Governor noted that at a time of recession, there might be concerns that this measure would detrimentally impact the economy and job prospects, and there would be merit in consulting on the measure before implementation.

Council agreed that Ministers of Government should revisit the paper and consider whether they wished to amend the legislation to allow for a moratorium.

- (ii) the term of the Licence would be for five (5) years terminable by three (3) months' notice by either side;

- (iii) the use of the premises would be commercial;
- (iv) an option to renew for another five (5) years;
- (v) an annual rental of US\$600.00 with the option to pay in monthly installments of US\$50.00 each; and
- (vi) Mr Bryson must pay the outstanding rent in the amount of US\$2,150.00 for the period 1st March 2010 to 30th September 2013 prior to the issue of the Licence.

Council noted that Ms Gecheal Richardson, Financial Controller representing the GoA, had been removed from the list of persons to serve on the Committee. In light of this, Council suggested that it would be important to ensure a close GoA financial link on the Committee to ensure the prudent use of GoA funds.

Council further agreed that the Administrative Assistant should be responsible for the coordination of meetings, record keeping, dissemination of correspondence and oversight of the use of the carnival office and that she be paid a monthly stipend of EC\$500.00. Council queried whether stipends were paid to other members. The Hon Minister of Education stated that he believed that about three months leading up to the festival activities, the Chairman received a stipend and the other members, a gas allowance. The Minister indicated that he would find out from the Ministry of Social Development whether this was the position.

EX MIN 13/702 AWARD OF ANGUILLA ISLAND SCHOLARSHIP 2006

The Parliamentary Secretary remained for discussion. Ms Nakishma Rogers, Solicitor, Astaphan Chambers joined the Meeting.

Council granted the opportunity to Ms Nakishma Rogers to express her views on the matter of the 2006 Island Scholarship, in which she was selected for the second Anguilla Island Scholarship for 2006 to pursue five years of training covering the LLB programme at the University of the West Indies and the Legal Education Certificate, at the appropriate regional institute, up to a cost of EC\$500,000.00.

Council noted that the 2006 Ex Co decision required Ms Rogers to apply through the established Training Policy process if she wished to pursue further studies.

Council, cognizant of the agreed policy for establishing priority training needs through the Training Policy Committee, and the reduction in training budgets for 2014, agreed that Ms Rogers, following on from the support already received since 2006, should be asked to present in writing to the GoA the exact area of training she wished to pursue at the Masters level. The Hon Minister of Education, who would be off island next week on official business, indicated that he wished to have the matter further addressed, and requested that it be placed on the agenda for the next meeting of Executive Council at which he would be present.

EX MIN 13/703 APPROVAL OF BRAND REALIGNMENT EXERCISE BY THE BRITTO AGENCY

The Parliamentary Secretary remained for discussion.

Council discussed the financial implications of the proposal from the Tourism Oversight Committee to spend an additional EC\$3.34 through The Britto Agency on branding and publicity events to support Anguilla's tourism sector. Council-

- (i) agreed that the PS, FIN and the PS, EDICT should be asked to comment on the implications of this additional spending proposal on GoA's draft budget for 2014:
- (ii) queried whether paragraph 8 of the paper was a part of the 2014 Budget and whether the proposals were factored in the 2014 Budget proposals; and
- (iii) agreed that the matter should be discussed at a future Council meeting with the relevant Permanent Secretaries present given the implications for the 2014 GoA budget.

HE The Governor noted that if agreed, these spending proposals would bring spend on The Britto Agency to around EC\$3.85m, or approximately 2% of GoA's

total budget for 2014. Given these proposals were not currently included in the 2014 Budget, equivalent savings would need to be found from other budgets.
