31/10/2013: STATEMENT REGARDING EXCO MINUTES OF 28^{TH} OCTOBER 2013 PREPARED BY: HON. JEROME ROBERTS MINISTER WITH RESPONSIBILITY FOR EDUCATION

I wish to place on record my position as expressed in EXCO relating to the Nakisma Rogers scholarship matter.

I received a copy of a letter sent to Ministers of Government sometime in February 2013 from Ms. Rogers outlining her concerns as it related to the Scholarship which she was awarded as one of the Two Island Scholars in 2007. (A copy of which forms part of EXCO minutes)

As Minister of Education I sought to get some clarity on this matter by raising it at EXCO seeing that Ms. Rogers had informed me that she wrote to the Deputy Governor Mr. Stanley Reid some time earlier expressing her concerns on the said matter.

After hearing out the DG at EXCO on this matter I was not pleased with his response and deferred the matter as I carried out my own investigation.

To set the record straight on 23/3/2006 EX MM 06/15 reference to The Anguilla Island Scholarship a decision was made by the then Government "to continue to award scholarships for training up to the level of postgraduate degree, where the scholarship recipient requests such training and its relevance to Anguilla in both the short term and the long term could be ascertained".

On the 18/1/2007 EX MeM 07/14 reference Award of Anguilla Island Scholarship 2006 there were two recipients namely Ms. Monifa Fahie and Ms. Nakiskma Rogers. Ms. Fahie was funded up to the Masters level for her course of studies and in the case of Nakishma Rogers this was not done instead she was asked to apply for a scholarship to pursue her Masters.

Now here is where I felt that the process was not fair to Ms. Rogers who was at the time also identified as an Island Scholar. I made this concern known in EXCO and further went on to say that we ought to treat our Island Scholars differently from other scholarship recipients.

HE the Governor made a statement in EXCO during these discussions "that's why PS children should not be granted scholarships". I indicated to HE that the Island Scholarship has nothing to do with PS children but the ability of the children to excel and as such they should be treated fairly. I also took the statement by HE the Governor to be unfortunate and discriminatory.

At a later discussion on this matter and following further research it was revealed to me that when Ms. Rogers obtain the Scholarship went in fact her mother PS Kathleen Rogers was NOT a PS at that time. However since I found HE comments to be funny with regards to PS's children I had to interject that when the Deputy Governor Mr. Stanley Reid received his funded scholarship up to the Masters Level went his Father was a Minister of Government and that is a fact.

The decision made by EXCO on the 28^{th} October has nothing to do with the fact that Ms. Nakisma Rogers is the daughter of a PS it has to do with being fair and transparent in executing processes.

If we are speaking about fairness and openness then let's clear the air on all that transpired in the pass and what is transpiring now.

I also indicated that in 2010 when a paper was presented to EXCO referencing returning students whom the government sent out on scholarships for a decision to be taken to relieve them of their bond due to the financial situation these two Island Scholars were part of that listing. I asked the Deputy Governor Mr.

Stanley Reid why wasn't some special arrangement made to at least recognize these two Students and he indicated that they should Not have being treated differently so EXCO took a decision guided by Public Administration under the watchful eye of the Deputy Governor to relieve these two Island Scholars of a placement in the Public Service.

I stated that this was Not fair to them and I still maintain that and I know that if I was present at the time of that decision it would not have happen.

During my investigation process I discovered that just before these students were to return a position to which Ms. Nakisma Rogers could have taken up in the AG Chambers was removed from the budget. Today we have Island Scholars returning home and being placed without the job being advertised under the watchful eye of the Deputy Governor (Investment and Trade Officer).

The EXCO decision made on the 28th October has history to it for there was another similar case in the AG Chambers where Dawn Richardson also fell in this position and the AG at that time had to bring the matter before EXCO and she was granted her studies which she so rightly deserved.

In 2010 this administration being fair to our Island Scholars and in keeping with the 2006 Ex MEM 06/15 afforded Ms. Ojeda Vanterpool our Island Scholar at the time with a fully sponsored scholarship right up to the Master level the daughter of Parliamentary Representative for Island Harbour Hon. Othlyn Vanterpool and her Mother Education Officer Assessment, Testing and Measurement in the Ministry of Education Ms. Colleen Horsford. Additionally her Aunt Mrs. Lena Harrigan is the Director Human Resource at Public Administration. It was not done on the basis of who were her parents or who she is related to; it was done because she qualified for such through her academic achievements.

Ms. Vanterpool was granted her scholarship right up to the Masters of Law (LLM) while the Deputy Governor sought to mislead EXCO that the Legal Education Certificate was considered to be at the Masters level. Additionally, Ms. Vanterpool did not have to apply to do the Masters of Law (LLM) as Ms. Rogers was made to do and denied. Ms. Nakisma Rogers did not seek a back door audience on this matter she when through the proper channels to have her case heard by writing to the Deputy Governor and the Ministers of Government.

The Deputy Governor statement in the minutes of 28th October leaves me to ask "what has he done about the perception to which he speaks as it relates to the credibility of the scholarship process being corrupt and not fair and upright?" His actions does not lend credence to his same statement. This appears to be personal taking into consideration the lengths that the Deputy Governor has taken so far to opposed the granting of the scholarship up to the Masters for Ms. Rogers.

Was the process fair when the Deputy Governor got his Legal Scholarship fully funded to the Masters level when his Father was a Minster of Government and sat in EXCO? Why should it be different now? What we have done here is to seek to create a level playing field and to treat our Island Scholars with a sense of dignity and prided regardless to who they are for. These are our human capital and we must and should do whatever is possible to treat them as such.

In closing I would repeat what I mentioned earlier this decision has nothing to do with Ms. Nakisma Rogers's mother being a PS in government it all has to do with us doing what is right.
