EX MIN 14/159 CONFIRMATION OF THE MINUTES

Council agreed that the Minutes of the 185th Meeting held on Thursday 6th March 2014 should be confirmed at the continuation of the Meeting of Executive Council to be held on Monday 17th March 2014 at 9:00 am.

EX MIN 14/160 MONETARY ASSISTANCE TO THE BRITISH DEPENDENCY BAND

Mr Foster Rogers, PS, EDICT and Mrs Candis Niles, Director of Tourism joined the Meeting.

Council agreed that monetary assistance should be given to the British Dependency Band, through the Anguilla Tourist Board, who are currently touring the USA and promoting Anguilla. Council noted that through no fault of the Band there was a delay in realising funding arrangements. This resulted in the Band needing US\$9,000.00 to facilitate transport arrangements while on tour. Council further agreed that the Ministry of Tourism should fund this expenditure through an appropriate mechanism.

Council noted the power point presentation made by Royal Engineers, Major Andy Nixon, and Warrant Officer 2 Carl Green, with regards to the structural survey of the Road Bay Jetty. Council recognised that the Road Bay Jetty was in an advanced state of deterioration.

Council agreed with the recommendation from the engineers that some urgent repairs needed to be undertaken and operational restrictions implemented immediately to prolong the life of the jetty.

The CEO (Ag.), AASPA informed Council that he had had a meeting with the shipping agents, the Management of AASPA and other relevant personnel who have agreed with the proposals going forward. The CEO (Ag.), AASPA indicated that he intended to approach the GoA for financing for the project before the final report was submitted by the engineers.

Council further agreed that given the declining state of the jetty urgent steps had to be taken as a temporary measure and that the long term vision of a proper functioning pier at the designated location should be maintained.
