Following a site visit to the property at Island Harbour on 26th March 2014, Council was minded to allow the appeal against planning permission for Mr Warren Webster to construct a Bar and Restaurant at Island Harbour, Anguilla, (Block 89319B, Parcel 74), subject to satisfaction of the requirements contained in points (v) and (vi) of EX MEM 14/86.

Council agreed that Mr Karim Hodge, Director, Environment should be invited to Executive Council to update Council on the administrative process for issuing Beach Vending Licences.

**EX MEM 14/89 APPEAL AGAINST PLANNING PERMISSION –

Council noted that the Hon Minister of Home Affairs and Planning met with members of the Anguilla Drag Racing Association on 17th February 2014 to review the proposals for the establishment of the drag racing strip at Corito Anguilla.

- (i) what the likely costs of this operation would be (to include Environmental Impact Assessment, design, building, operation and maintenance of race track); and
- (ii) other associated costs.
