- (iii) noted the estimated cost of the project is between EC\$5 5.5 million;
- (iv) noted that the approved funding for the project is EC\$1million from UKG and EC\$1million from EDF funds identified in the 2014 GoA budget was not sufficient to complete the project. Although UKG funds were available, there was uncertainty as to how much and when the EDF funds would be available:
- (v) noted the increased scope of the project to address the issues with air traffic control tower may have an impact on priority and scheduling of other projects.
- (vi) directed that the Deputy Governor and Permanent Secretaries review and make recommendations as to how the capital projects can be delivered, being conscious of the current funding arrangements, the priorities of Ministers and the absence of identified funding sources for capital projects to be completed in 2015.

EX MEM 14/114 LEASE OF CROWN LAND BY TAMARA GUMBS & TAYNA GUMBS – PROPERTY DESCRIBED AS REGISTRATION SECTION NORTH, BLOCK 58814B PARCEL 2, CONTAINING APPROXIMATELY 28 ACRES OF LAND, SAID PART CONTAINING 0.3 ACRE

Council agreed that a lease be granted to Tamara Gumbs and Tayna Gumbs on the following terms:

- (a) The property is described as Lot #1 containing 0.35 acre situate in Registration Section North, Block 58814 B, being part of Parcel 2 as shown on Survey Plan LS33-13.
- (b) The use of the premises is to establish a museum, lounge, restaurant and retail facility at the Old Valley Well in the Valley.
- (c) A sewage treatment plant must be installed at the facility that meets the requirements of the Land Development Control Committee and the Water Corporation of Anguilla. This will be installed by the Lessee.
- (d) The roof at the facility must be designed in accordance with the design of the existing buildings in the area.
- (e) The guinep trees must remain in the area.
- (f) The parking lot must be developed by the Lessee to the requirements and standards approved by the Chief Engineer at the Department of Infrastructure, Communication, Utilities and Housing.
- (g) That no works shall be caused or executed for the demolition of the said buildings considering their historic importance or for their alteration or extension in any manner which would affect their character, unless the works are authorized by the Land Development Control Committee.
- (h) The term of the lease is fifty (50) years with an option to renew up to 99 years.
- (i) A rent per annum in the amount of US\$8,400.00 (EC\$22,580.88) to be payable annually in advance for the first five (5) years. Thereafter, the rent shall be reviewed at the end of every fifth (5th) year of the lease to Market Rent but in no event shall the percentage increase in rent on review be less than 10% of the rent payable prior to the review. [COMMENT FOR PUBLICATION: this paragraph revisited in ExCo minutes of 10/4/14]
- (j) Stamp Duty payable is as follows:

Open market value of the property is US\$83,600.00 or EC\$224,733.52

Stamp Duty on Lease EC\$224,733.52 x 50 x 0.0005 = EC\$5,618.34

- (k) That the Lands team draw up a lease to be cleared by the Attorney General's Chambers for execution by the applicants and the Government of Anguilla.
- (l) The Government of Anguilla to relocate the existing fence to the proposed leased area which involves the expenditure of Public funds in the amount of EC\$4,330.25.

EX MIN 14/230 **FINANCIAL SERVICES LEGISLATION**

The Governor noted that Anguilla's Phase Two review by the OECD Global Forum on Tax and Transparency was scheduled for June; however, the legislative amendments prescribed in Phase One had yet to be implemented. This was disappointing given that ExCo had agreed the Financial Services (Miscellaneous Amendments) Bill and the Confidentiality Relationships (Amendment) Bill, and these had been introduced to the Assembly in February. It would be helpful if these could be brought again to the Assembly in the coming weeks, as failure to do so soon would put Anguilla at real risk of getting a negative review for phase 2, damaging its international reputation, and ultimately impacting on our competitiveness in this key sector.

Ministers agreed that, subject to date confirmation by the Speaker, these Bills should be considered at a meeting of the Assembly on 28 April.
