The Hon Attorney General indicated that legislation addressing Fronting already existed and undertook to review it and to come back to Executive Council with further information. Council reminded the Hon Attorney General to provide that information to Executive Council on the Fronting Legislation.

Council further noted the draft press release regarding the Government of Anguilla 2014 Legislative Priorities. Council agreed that Ministers would decide when the press release should be sent out.

EX MIN 14/246 EX MEM 14/126 2014 CAPITAL BUDGET – PRIORITISED IMPLEMENTATION OF UKG FUNDED PROJECTS

DLS remained for discussion. Mr Foster Rogers, PS, EDICT and Ms Anthea Ipinson, Chief Projects Officer joined the Meeting.

Council:-

- (i) agreed that the Fire Station and Air Traffic Control Tower should be given priority for the 2014 Capital Budget;
- (ii) noted that other capital schemes identified in the 2014 Budget, including (but not limited to) the Adrian T Hazell Primary School, Minor Education Projects, Telecommunication Tower Replacement, and road development would need to be carefully prioritised. This was needed to reflect both the fact that the Fire Station/Air Traffic Control Tower was expected to cost more than had been envisaged at the time the Budget was agreed, and also the expected delay in the final disbursement of the EDF 10 Programme Fund; and
- (iii) further agreed that a proper detailed discussion on prioritisation across all capital projects should be held between Ministers of Government and officials in the relevant Ministries to agree the way forward.

EX MIN 14/247 **AASPA APPOINTMENTS**

HE The Governor was mindful that the final decision for the appointment of a CEO, AASPA remained with the Hon Minister, MICUH, but explained that she had written to the Chair of AASPA to express her serious concerns regarding the appointment process for the CEO, AASPA. In her view, the process had not been carried out in accordance with the principles of good corporate governance, and had resulted in the appointment of a different candidate to that recommended by the independent interview panel. She has written mindful of her responsibilities for ensuring public authorities are run to high standards of probity and transparency, and for safety and security at ports, but also because the wrong candidate being appointed risked damaging efforts by the Government of Anguilla to improve access to the island, which was crucial for the economy.
