- (ii) agreed that the Department of Environment should be the national focal point for ocean governance matters;
- (iii) agreed that Anguilla should be part of the OECS Hydrographic Survey project;
- (iv) agreed that Anguilla should request technical and financial assistance from the Commonwealth Secretariat for the continued development, completion and national approval of Anguilla's National Ocean Governance Policy;
- (v) agreed that the National Ocean Governance Team should also be responsible for Maritime Boundary Delimitation giving it's interrelatedness and the fact that it will avoid duplication of skills and resources;

- (vi) noted the need to amend the relevant sections of the Fisheries Act and Regulations to reflect the term "Exclusive Economic Zone" instead of "Exclusive Fisheries Zone";
- (vii) supported the development of a comprehensive Maritime Zone Act to ensure that the island claims what is legally afforded in line with the UNCLOS. Officials are requested to come back to Executive Council in due course to have the relevant drafting instructions considered; and
- (viii) agreed that Anguilla should formally request Her Excellency the Governor to inform the Foreign and Commonwealth Office that Anguilla needed immediately to finalise all of its marine boundary delimitation issues.

HE The Governor requested that a draft of the letter to be sent to the FCO be prepared for her consideration.

Council thanked the team for the comprehensive presentation and hard work.

- 1) formally open discussions with the US with the submission of The Agreement between the Government of the United States of America and the Government of Anguilla to Improve International Tax Compliance and to Implement FATCA, along with its associated Annexes;
- 2) seek exemptions for FATCA reporting for:-
 - (i) a trust domiciled under the laws of Anguilla, specifically the Trusts Act RSA c. T70 must have an Anguillian trustee which must be licensed under the Trust Companies and Offshore Banking Act RSA c. T60;
 - (ii) an Insurance Company licensed under section 3(1)(b) (f) of the Insurance Act RSA c. 116 which uses an insurance manager domiciled in Anguilla and licensed under the same Act inclusive of captives; and

- (iii) a Mutual Fund domiciled in Anguilla and licensed under the Mutual Funds Act RSA M107 which uses an Anguillian licensed mutual fund manager and or administrator.
- 3) work with AFSA to host a FATCA seminar for interested persons.

 - Scott Hauser & Chrislyn Hughes: Two members appointed by the Minister, after consultation with the Anguilla Hotel and Tourism Association;
 - c. **Simone Connor**: One member appointed by the Minister after consultation with the Chamber of Commerce;

- d. **Adeta Gumbs**: One member appointed by the Minister from among persons engaged in transport services;
- e. **Condon Proctor**: One member appointed by the Minister from among persons, other than owners or managers employed in the tourism industry, after consultation with the president or other chief executive officer of the representative body or organization representing such persons, and, where no such body or organization exists, then such persons as the Minister believes best represent the interests of persons employed in the tourism industry; and
- f. **Oliver MacDonna**: One other member appointed by the Minister.
- (iii) further agreed that Ms Bonnie Bloom should serve as Chair to the Anguilla Tourist Board.

- 6) the development of a policy to guide Government in the official recognition of Anguilla's revolutionary heroes and heroines and other prominent Anguillians when they die.
