Parliamentary Secretary, PA to Hon CM/Finance and PS, EDICT remained for discussion. Dr Aidan Harrigan, PS, FIN and Mr Andrew Gumbs, Director of Internal Audit joined the Meeting.

Further to EX MIN 14/342 of 22nd May 2014, Mr Andrew Gumbs, Director of Internal Audit informed Council that he had interviewed employees at MICUH and Mr Ivor Greene at the Attorney General's Chambers. He indicated that he had to meet with Mrs Sandra York-Gumbs who had the relevant files pertaining to the matter, but stated that Mrs York-Gumbs was off island and would be back next week. Mr Gumbs said that the investigation was in progress and that the facts would be reviewed thoroughly before coming to a reliable conclusion.

With reference to the interview of person/persons from St. Maarten/St. Martin, the Director indicated that, that might require police involvement.

EX MIN 14/366 EX MEM 14/199 GOVERNMENT'S POSITION ON SUPPORT FOR DRAG RACING

Parliamentary Secretary, PA to Hon CM/Finance, and PS, FIN remained for discussion.

Ministers were minded to support the granting of financial contributions for overseas events pertaining to Drag Racing. They noted the growing passion for this sport and were supportive of the efforts of the Drag Racing Association in advocating for the construction of a properly equipped race track. The Governor pointed out the potential difficulty in funding an activity that was illegal in Anguilla, given the possibility that funds may be used to test vehicles on Anguilla's roads. This was not just illegal but posed a threat to public safety.

Council tasked officials in the Ministry and Department of Sports, the MoFEDICT and other relevant departments to work out what steps would need to be taken to address the concerns raised. Council requested that a detailed paper be brought back to Executive Council for further consideration. Once addressed, then the Sports Department's budget for 2015 Budget and onward would be able to consider funding from the Drag Racing Association in the usual way alongside bids from other sporting organisations.
