Council:-

- (i) noted the recommendations of the Training Policy Committee as outlined in EX MEM 14/288;
- (ii) agreed that, in addition to those areas identified by the Training Policy Committee, Pharmacy should be included as a priority training area;

(Council noted the scholarship offered in this area by Altamer Resort and agreed that there should be discussion between Altamer and the GoA as it relates to this particular area of study)

- (iii) agreed that there should be further discussion on the Bachelor Degree in Civil Engineering;
- (iv) agreed that clarity be given by the Training Policy Committee as to whether the GoA should fund training up to the Masters level if the candidate was not an Island Scholar:
- (v) noted the projected uncommitted balance of EC\$323,940.54 for the remainder of 2014; and
- (vi) additionally noted the ministerial decision to fully fund the following persons for the duration of their studies:-
 - 1) Mr Kumakie Parris Psychology, Argo University, USA
 - 2) Ms Jilma Hodge Medicine, Dominica
 - 3) Ms Nakishma Rogers LLM, University of London

Mrs Kathleen Rogers, PS, PA and mother of Ms Nakishma Rogers left the meeting and was not a part of the discussion relating to her daughter.

HE The Governor said that the decision to support particular students in subject areas that had not been identified as priorities by the Training Policy Committee was likely to undermine public confidence in the process by which scarce Government funds were allocated. In addition, the consequence would be that skills gaps could not now be funded, and as a result Anguilla would continue to have skills shortages in important areas.

Following the decision taken by Ministers of Government to fully fund the above persons for the duration of their studies, Council asked that the following statements be placed on record:-

Hon Minister of Education

"Kumakie Parris - the Government of Anguilla has the right to assess any area of priority training that is brought before them and to make the adjustments where necessary. In this particular case, Kumakie Parris was a troubled youth whose desire is to assist other troubled youth and as a result of his experiences saw the need to further advance himself educationally. The GoA wholeheartedly supports such a request."

"Jilma Hodge – the Government of Anguilla, cognizant of the fact that this was not a priority area outlined, recognised the need to assist her in her final course of study".

"Nakishma Rogers – an Island Scholar and not just an applicant for a scholarship. The Government of Anguilla again recognising that there is need for fair play wholeheartedly support Nakishma's studies towards the LLM. The Government recognised that as an Island Scholar she was awarded approximately EC\$500,000 for her course of studies. She completed the first portion of her studies and used approximately EC\$350,000 of what was awarded for her studies thus creating significant savings to the Government of Anguilla. It must be noted that Nakishma Rogers who worked at the Attorney General's Chambers at every opportunity when she was home on vacation was never looked at for placement within the Government of Anguilla. The approved area of study to date is going to be to the tune of EC\$50,000 which shows that there would be significant savings of approximately EC\$100,000 as it relates to Nakishma's studies as Island Scholar of Anguilla".

Hon Chief Minister/Finance

"I am very happy that my 50 years of involvement in trying to secure a serious, reputable Government in Anguilla has now been rewarded by the type of Ministers I have on my left in the person of Hon Jerome Roberts and Hon Evan Gumbs. In the history of the Government of Anguilla we have never had a Government so clean and decent. We are even more stressed by the fact that the portfolios we carry are so burdensome and we hardly have time for ourselves. I listen here most of the time and make very little comment. There is serious instability amongst our youth. If I would see Kumakie, I would not even know who he is. I have no interest in him but the fact that he heard about his events to save the youth, any reputable Government would want to encourage him for what he is doing".

"Jilma – a very good Nurse in Anguilla. It makes very good sense what the Minister is proposing".

"Nakishma – I wish to state unequivocally that this brilliant young student has been seriously victimised. Because Kathleen Rogers is her mother, her daughter was victimised. I had a similar experience with a nephew of mine. I have known Nakishma coming back from University and committing to the AG's Chambers which means she was committed to working in Anguilla. The AG's Chambers said she was a good student and would be an asset to the Chambers and Anguilla. I support the Minister's actions".

Hon Minister, MICUH

"I am in full support of Minister Roberts' position".

Council asked for a comprehensive report to Executive Council of all the Island Scholars who have returned to Anguilla since 2010, specifying those who have been placed and those who have not been placed. Their course of studies should be included.
