HE the Governor expressed concern that technical expertise had not been sought to ensure that the GoA was signing off on a business plan that was delivering value for money.

Minister Roberts stated that the GoA London Office was making a significant contribution to the objectives of Anguilla, and compared to the sums being paid for permanent London offices by other Overseas Territories in the Caribbean, for example Montserrat and Cayman, represented very good value for money.

### EX MIN 14/600 EX MEM 14/346 REPATRIATION OF THE PRINTING OF ANGUILLA PASSPORTS TO THE UNITED KINGDOM

Mrs Kathleen Rogers, PS, PA joined the Meeting.

Following discussion of the paper, Council noted the following concerns expressed by Ministers of Government:-

### Hon Chief Minister

"I had never supported the idea of repatriation of Anguilla passports to the United Kingdom".

### Hon Minister of Home Affairs

"I am not in full support of the repatriation of the passports taking into consideration the number of uncertainties still to be agreed upon. This mechanism is serving to increase expenditure on our scarce budget resources and will indeed reduce revenue. This information has to be disseminated and a statement of some nature should be made sooner rather than later to the people of Anguilla. This is something that was not budgeted for and it is a cost. Where is this extra cost coming from? It is a cost that the people of Anguilla have not factored in and I am not hearing from the FCO their willingness to contribute to a request mandated by them. Despite my objection concerning this, I have no other choice but to agree".

#### Hon Minister, MICUH

"I am not in support of the repatriation of the passports unless there is public consultation and the people of Anguilla decide. I need to hear the views of the people".

HE The Governor explained that plans to repatriate the printing and issuing of BOTC passports to the UK had been taken some years ago, and that consultations with OT Governments had been taking place since then. Ministers had had the chance to raise concerns, e.g. at last December's Joint Ministerial Council, but had not done so. At this late stage, it would be not be possible to reverse the move, and so the priority should be on ensuring the transition was as low-cost and smooth as possible. The change would allow BOTC passports to contain more sophisticated features that met increasingly strict international standards, and improve security while enhancing Anguilla's status as a modern passport issuing authority. The UK Government was also seeking confirmation from the US authorities that the new passports would be accepted under the US visa waiver programme - a significant help to BOTC citizens.

Council nonetheless agreed to:-

i) the signing of the agreement with WorldReach and authorised the PS, PA to sign the document on behalf of the GoA;

- ii) the allocation for the payment due in 2014 from the 2014 budget and the inclusion of the expenditure associated with the repatriation in the 2015 budget if no alternate means of funding is identified; and
- iii) the cost associated with making the Passport Office more secure.
