Council noted that the GoA was presently in the process of acquiring title to lands described in Registration Section South Central, on Block 38713 B Parcel 257, Parcel 25 (Part of), Parcel 59 and Parcel 88 (Part of) to allow for the lease to be

registered between the Crown and the Anguilla Air & Sea Ports Authority as declared under Section 115 of the Anguilla Air & Sea Ports Authority Act, RSA c A57.

Council agreed that in order for the Clayton J. Lloyd International Airport lands to be amalgamated and vested in the Anguilla Air & Sea Ports Authority Act, RSA c A57 that EX MIN 13/693 of 10th October 2013 should be amended to delete item (ii) (2) and replace it with the following:-

- (i) the amalgamation of Crown Lands as delineated on Survey Plan LS18-14; and
- (ii) the lands to be vested in the Anguilla Air & Sea Ports Authority are as delineated on Survey Plan LS04-15, subject to a revised schedule being drafted by the Attorney General's Chambers and gazetted by MICUH.

EX MIN 15/139 **DISSOLUTION OF THE HOUSE OF ASSEMBLY**

HE The Governor informed Council that the Hon Chief Minister had called on her and had written to ask that the Assembly be dissolved with effect from Wednesday 25 February 2015. A proclamation to this effect would therefore be issued the following morning. A date for the election had not yet been indicated. Guidance, which had been approved by Executive Council, had already been issued to public servants to inform them of the principles that inform decision making between the dissolution and the election. That guidance makes clear that:-

"the dissolution of the House of Assembly does not affect the day-to-day business of the Government. Executive Council members remain in charge of their portfolios. Following the dissolution of the House of Assembly it is, however, expected that Ministers will refrain from initiating any action of a continuing or long-term character. Decisions on matters of policy, board appointments and other issues (for e.g. large and or contentious procurement contracts) on which a new Government could reasonably be expected to want the opportunity to take a different view from the present Government should be postponed until after the election, where such postponement would not be detrimental to the national interest nor wasteful of public money."

Ministers confirmed that they were mindful of the guidance and would conduct their business accordingly.
