EX MIN 15/258 NON ANGUILLIAN CIVIL SERVANTS OVERSEAS

The Hon Minister of Home Affairs suggested that it would be a good idea to remove the charges currently levied on non-Anguillian public servants to register their children for immigration purposes. Such officers, including many who put themselves at risk in the line of serving Anguilla (e.g. in the RAPF or prison service), were performing essential functions for the Government of Anguilla. The additional charge for registering their children should therefore be removed or zero-rated.

ORAL STATEMENTS

EX MIN 15/259 HON CHIEF MINISTER

I wish the minutes of the Executive Council to reflect a final statement from me as I plan to demit office after the April 22^{nd} general elections.

As a native born Anguillian, I have made many sacrifices as I endeavoured to serve Anguilla in a political role over the better part of my life. I even abandoned a very successful and comfortable life in the UK where I resided collectively up to a period of 8 years.

I returned to Anguilla first in 1961 to contest elections as this island had then a single candidate in the three island colony of St Kitts – Nevis – Anguilla. When I failed to win the seat, I returned to the UK in 1962 coming back finally to Anguilla in 1964.

I finally got elected as the lone opposition member, following the general elections of 1976 under the first Anguilla Ministerial Constitution of 1975. In 1977, I was appointed Political Advisor to the Emile Gumbs Government, and after 1980 elections I became a leading Minister in the Government of Mr Ronald Webster.

In 1994 and 1999 I was twice sworn in as Anguilla's Chief Minister. Finally I became Chief Minister in February 2010.

During my time in and out of government, I have fought against Administrative corruption and paid heavily for doing so.

My main frustration has been with the failure with the FCO and with its chosen officials including a succession of Governors to ensure good governance. On numerous occasions I have pointed out clear cases of official corruption – far too much to be detailed in this statement to our British Governors but to no avail. I even supplied names of offenders and gave evidence of their corrupt deeds. An English doctor who was invited to Anguilla to perform a special assignment eventually abandoned the project stating that Anguilla ranks among the ten (10) most corrupt countries in the world.

My experience is that official corruption is covered up by those responsible for exerting discipline. I will continue to tackle corruption as long as I live. No one is currently being challenged. There needs to be a code of ethics, including for politicians.

I wish Anguilla all the best and the future government whoever it may be. Thanks to my Ministers for their support including Mr Baird. I wish Mr Hughes all the best as he exits office. This is not a farewell but 'see you later'.

At your final Executive Council meeting, let me add that it has been a pleasure working with you Chief Minister. We have not always seen eye to eye, but I

have appreciated the courteous way in which we have thrashed out our disagreements.

I have repeatedly endorsed your comments that we need to tackle corruption in any area, be that in politics or in the public service. I would therefore encourage you again, as I have done on other occasions, to share with the police any evidence you have of corruption or criminal activity, so that it can be investigated in the proper way.
