# EX MEM 15/172 APPLICATION FOR ISSUE OF LICENCE UNDER THE ALIENS LAND HOLDING REGULATIONS ACT – JAMIE CHRISTOPHER FIELDS – REGISTRATION SECTION EAST END, BLOCK 99519 B, PARCEL 73, CONTAINING 0.94 ACRE

b) the construction of the dwelling house to be completed within twenty-seven (27) months (i.e. twenty-four (24) months for construction plus three (3) months for the relevant permits to be obtained); and

c) with the expressed condition that the land is to be used for residential purposes and that the Licencee must not rent his dwelling house unless an application is made and written permission is obtained from the Ministry of Finance, Economic Development, Investment, Commerce, Tourism and Lands & Physical Planning (FEDICTLP).

## EX MIN 15/331 EX MEM 15/176 MAINTAINING THE COMMODITY SUPPLY CHAIN OF GOODS TO ANGUILLA

Parliamentary Secretary remained in attendance. PS, EDICT and DLS remained for discussion. The following persons joined the Meeting:-

#### Council:-

- (i) noted the power point presentation on the status of the Road Bay Jetty;
- (ii) approved the recommendations in the Royal Engineers Report (Option 1, paragraph 40, pages 8-9) for the urgent and priority implementation of critical remedial repairs to the Road Bay Jetty at an estimated £665,000 (EC\$3,060,000), as a first essential phase to avert structural failure and the attendant economic and social costs;
- (iii) approved the Royal Engineers recommendation (Option 3, paragraph 42, pages 9-10) for the construction of "new RO-RO berthing platforms at the end of the jetty and along the southern edge" at an estimated cost of £2.5

- million (EC\$11,503,759) as the second phase of the rehabilitation of the Jetty to meet Anguilla's medium term cargo port RO-RO needs;
- (iv) agreed that funding needed to be urgently sourced to undertake the critical remedial repairs to Road Bay Jetty and to construct the RO-RO berthing platforms by means of a grant;
- (v) agreed that, in the event a grant is not obtained, a soft loan should be sought. If this method is unsuccessful, recurrent revenue surpluses should be used, which, if that proves also to be unavailable, a portion of the reserves should be used; and
- (vi) agreed that the UKG should be asked if technical assistance could be provided for the design phase and the remedial repairs to the Road Bay Jetty.

In a further discussion, Council acknowledged that the AASPA needed to be self financing and should not continue to rely on the GoA for funding. Council mandated the Ministry of Finance and the MICUH along with the AASPA to have a discussion on the AASPA's ability to finance a loan for the immediate repairs to the Road Bay Jetty. AASPA Executive Officers were asked to look at the long term options for the Road Bay Jetty and additionally to work through what a contingency plan would look like if the Road Bay Jetty was no longer available for use.
