## EX MIN 15/535 EX MEM 15/307 APPROVAL FOR REVISED CONTRIBUTIONS FOR THE HOLDING OF NATIONAL FUNERALS IN ANGUILLA

Parliamentary Secretary remained in attendance.

#### Council:-

- (i) agreed that the conduct of State or National Funerals, by nature of their national significance and importance should always attract some level of financial input by Government. The quantum of this contribution, as set out below, may change from time to time, but would always form an important component of the event. It is always at the discretion of the family or relatives of the person being granted a State or National Funeral to decline the financial contribution or other aspects of the State or National ceremony, but this should be left up to the discretion of the family or relatives and not the discretion of Government;
- (ii) agreed that the section of EX MIN 15/475, wherein Council agreed that in the future the Ministry of Home Affairs should consider a process whereby the contribution of EC\$8,000.00 would be granted where it could be established that the family required such financial assistance, be revised in accordance with iii and iv below;
- (iii) agreed that the contribution of EC\$8,000.00 should be reduced to EC\$5,000.00 with immediate effect;
- (iv) agreed that the remaining EC\$3,000.00 should be disbursed as follows:-

(v) noted EX MIN 14/612 (vii) of 2 October 2014 which approved the holding of national funerals for persons awarded the Anguilla Badge of Honour and Queen's Certificate under the Revolution, moving forward, and Council to be informed;

- (vi) additionally noted the Information Note (as attached) regarding the number of national funerals to date;
- (vii) agreed that, in the case of persons being awarded the Anguilla Badge of Honour and Queen's Certificate under Social Development that, as is being done for the Revolutionary heroes, flags should be flown at Half Mast and a Statement of Condolence be published, moving forward. No financial contribution would be provided. This would also help to create a clear distinction between those honoured under the Revolution and those under Social Development; and
- (viii) was reminded of the draft Honours and Awards Policy that was last tabled in May 2013 to be further considered by Executive Council.

### IMPROVING AIR ACCESS FOR ANGUILLA – SHORT AND MEDIUM TERM

Parliamentary Secretary remained in attendance. PS, EDICTLP remained for discussion.

#### Council agreed that:-

(i) in the short term, the GoA through its departments and statutory agencies should work with the local operators and/or Anguillian owned foreign

carriers to improve air access, which would mean engaging with the likes of Anguilla Air Services, Trans Anguilla Airways and Rainbow International;

- (ii) given the current financial and other difficulties faced by Rainbow International Airlines, the GoA should provide a letter indicating that there were ongoing discussions with respect to the possibility of providing assistance to facilitate the resumption of the USVI, San Juan Anguilla service;
- (iii) the services of an appropriately qualified Consultant should be engaged to undertake a study of how to improve air access to Anguilla in the short term given the limitations of the Clayton J. Lloyd International Airport and the availability of air carriers and aircraft to serve the San Juan Anguilla route and the Antigua Anguilla route; and
- (iv) Council be updated on Thursday 5<sup>th</sup> November 2015.
