EX MIN 15/601 EX MEM 15/347 RE-CATEGORISATION AND FILLING OF CHAMBERS SENIOR CROWN COUNSEL (CRIME) AS CROWN COUNSEL (CRIME)

Ministerial Assistant, MHA and Ministerial Assistant, MICUHAF remained in attendance.

Council agreed that:-

- (i) a new post of Crown Counsel (Crime) should be created in the Attorney General's Chambers and filled; and
- (ii) funding for the new post should be paid from the personal emoluments budget which is to be increased to the extent of the salary of \$112,356. The professional and consultancy budget is to be reduced by the corresponding amount. This should reduce the total forward estimate for 2016 under Code 338 for Professional and Consultancy fees from EC\$1,741,687 to EC\$1,629,331 but increase Personal Emoluments at Code 310 from EC\$1,838.919 to EC\$1,951,275.

Council further agreed that the post of Senior Crown Counsel (Crime) would remain unfilled given the advice that three lawyers dealing with criminal matters was sufficient for current workloads. Future Executive Council approval would be required to change the structure of the criminal team. If then a decision was taken to fill the post of Senior Crown Counsel (Crime), it was envisaged that a post of Crown Counsel (Crime) would then be removed from the budget.

The Hon Attorney General updated Council on the progress of potential legislation prior to a Meeting of the House of Assembly on 3rd November 2015 as indicated below:-

1. <u>Domestic Violence Bill</u>

Council noted that instructions were being given so that committee stage amendments could be made and the Bill progressed at the forthcoming Meeting of the HoA on 3rd November 2015.

2. Legal Profession Bill

Council agreed to publication and public consultation regarding the revised draft Bill prior to the first reading on 3rd November 2015. Following the first reading, there should be further public consultation, to include the Chief Justice and Judiciary of the Eastern Caribbean Supreme Court, before the second/third readings.

3. <u>Special Advisers Bill</u>

Council noted the revised draft Bill and offered further guidance to the AG to facilitate the finalisation of the Bill.

4. <u>Anguilla Police Amendment Bill</u>

Council noted that the extended time for public consultation would end on 30th October 2015. Any further comments would be considered, and any amendments brought back to Executive Council, prior to any approval for the first reading. This would not be possible for 3rd November 2015.

5. <u>Contingency Banking Legislation</u>

Council noted that instructions were still being awaited before the formatting of the previously discussed contingency legislation.

The representatives further pointed out that their objective was to replace and maintain all agreed lights with LEDs and that one of the main advantages of this project was, guaranteed savings.
