Parliamentary Secretary remained in attendance. Ms Tina Bryan-Bannister, Head, AML/CFT & Enforcement at the Anguilla Financial Services Commission (AFSC) joined for discussions.

Council:-

- (i) noted that there was a need for an increase in certain fees relating to offshore bank licenses. The proposed fee increases were intended to reflect the workload and associated costs to the AFSC of reviewing an offshore banking application and conducting effective and proper supervision of offshore bank licensees. The proposed increase reflected the additional workload and cost due to the need to meet current international regulatory standards relating to both prudential regulation and AML/CFT oversight and remained in line with fees imposed by equivalent jurisdictions in the region, including Cayman Islands and BVI; and
- (ii) approved for signature by the Governor the proposed amendments to the Trust Companies Offshore Banking Fees Regulations.

EX MEM 15/410 APPEAL AGAINST PLANNING PERMISSION – ALKINS ROGERS (SUBDIVISION); OSBOURNE AND RUBY FLEMING (SUBDIVISION)

- (ii) noted Mr. Osbourne Fleming and Mrs Ruby Fleming (subdivision) APPL REF# 15/0051: Appeal be allowed;
- (iii) The Department of Physical Planning be tasked with drafting a policy that

allows subdivisions for parcels that have physical access to public roads by using adjoining roads that are either paved or maintained by the Government of Anguilla. This is required in view of the significant barriers to development and economic activity that may result from individuals not being able to subdivide land that has very good physical access to Public Roads, but portions exist that are either paved or maintained by the Government (as a public good) are either in the names of deceased individuals, or other persons who cannot be contacted and registered access cannot be obtained.

(iv) The Ministry of Infrastructure, Communications, Utilities and Housing to prepare schedules on paved roads and marled right of ways for Gazetting in order of priority. Thereafter, said schedule should be presented to Executive Council for consideration to quantify lands to be acquired for Public purposes and the potential financial implications involving such acquisitions.

- (i) that a lease be granted to ARA Holdings Anguilla Ltd (with its Director being J. Alexis Richardson) on the following terms:-
 - (a) The property is described in Registration Section North Central, Block 48814 B, Parcel 253 (part of) Lot 4, being 0.32 of an acre as delineated on Survey Plan LS09-09;
 - (b) The use of the premises is to establish an office building in the Valley;
 - (c) The parking lot must be developed to the requirements and standards approved by the Chief Engineer at the Department of Infrastructure in the Ministry of Infrastructure, Communications, Utilities and Housing by the applicant;
 - (d) The term of the lease is a fifty (50) year leasehold interest with an option to renew;
 - (e) A rent per annum in the amount of US\$2,300.00 (EC\$6,182.86) to be payable annually in advance increasing by Consumer Price Index (CPI) or two (2%) percent per annum, whichever is greater. At the end of every

fifth (5th) year of the lease the rent is to be reviewed to market rent upward only;

- (f) Stamp Duty payable is as follows:
 - (i) Market Value of the property is US\$77,427.00 (EC\$208,139.26);
 - (ii) Stamp Duty on Lease US\$1,935.68 (EC\$5,203.48);
- (g) The Department of Lands and Surveys drafts the lease and the Attorney General's Chambers finalises the lease for execution by ARA holdings Anguilla Ltd and the Government of Anguilla.
