PRESENTATION BY OFFICIALS FROM GLOBAL GREEN ENERGY LTD.

The following persons joined the Meeting:-

Hon Cardigan Connor, Parliamentary Secretary Mr Charles R. Carroll, Chief Executive Officer, Global Green Energy Ltd. Mr John Hayes, Vice President, Distribution, Global Green Energy Ltd.

The CEO and Vice President, Distribution of GGE Ltd. spoke of their continued interest in this project and of the fact that they had been granted conditional planning permission, a Memorandum of Understanding between the GoA and GGII of Anguilla Ltd., and a Services Agreement between the GoA and GGIIA for the Waste to Energy Project.

The CEO and Vice President briefed Council on the operations and activities of GGE Ltd. The CEO indicated that the company's main function was converting (not incinerating) waste into energy. He stated that GGE Ltd. would only use waste generated on Anguilla. The CEO further stated that by using pyrolysis (a thermal decomposition of complex organic matter in the absence of oxygen) which

causes everything to take place without oxygen, much more could be done than with other technology.

The Officials pointed out that they have been using the technology for over a decade and have reliable establishments in Korea, Philippines, Japan, Australia, Indonesia and Malaysia. The Officials indicated that relevant detailed information and contact details in Japan would be forwarded to Government Ministers for perusal and discussion.
