EX MIN 16/145 EX MEM 16/84 APPROVAL OF THE "SHAREHOLDER COMMITTEE" AS THE LEGAL REPRESENTATIVE FOR NATIONAL COMMERCIAL BANK OF ANGUILLA

Parliamentary Secretary remained in attendance. PS, FIN remained for discussion.

Council:-

- (i) agreed the proposed draft by-laws for the National Commercial Bank of Anguilla discussed between the Chief Minister and Minister Duddridge, subject to the tidying-up of a number of minor typographical and numbering errors;
- (ii) agreed to amend the by-laws of the existing company incorporated as the National Commercial Bank of Anguilla, rather than incorporating a new company;
- (iii) noted that, given this decision, and in line with the proposed by-laws, that Council would meet again in parallel to the meeting of the NCBA Board on 15 March to fulfil its responsibilities set out in those bylaws, including as Shareholder Committee;
- (iv) noted the Leader of Government Business's intention, in line with the proposed by-laws, that the three directors to be chosen from qualified resident Anguillians, to be nominated to the Board of NCBA would be:-

Mr Colville Petty – former Permanent Secretary Public Administration,

GoA

Mr Carl Harrigan - former Permanent Secretary Finance, GoA

Mrs Vida Lloyd-Richardson – Joint Owner/Manager of Davida's Restaurant and former HR Manager at Cuisinart Hotel

(v) noted the Leader of Government Business's intention, in line with the proposed by-laws, that the three Directors to be chosen from qualified regional persons to be nominated to the Board of NCBA would be:- Sir Errol Allen – former Deputy Governor of the ECCB Mr Marius St. Rose – former Vice President Finance of the CDB Mr Ian Chinapoo – Executive Director, Trinidad and Tobago Unit Trust Corporation

- (vi) noted the Governor's intention that, in line with the proposed by-laws, that the Director to be nominated to the Board of NCBA would be Mr Martin Dinning, and that he would act as Vice Chair;
- (vii) recognised that these recommendations for Board appointments would, once the agreed by-laws were adopted by the Board of NCBA, be confirmed as required by those by-laws by a meeting in parallel of the Shareholder Committee, and then immediately ratified by Executive Council;
- (viii) agreed to recommend to the Board that Mr Alex Richardson of Paragon Corporate Services should be appointed as an Interim Company Secretary and Legal Advisor for the NCBA; and
- (ix) agreed that those proposed Directors not already appointed as Directors of NCBA should attend the early start of the Board Meeting on 15 March as observers.

- (iii) requested that further information be sought from the ECCB about how the DPT(s) would work in practice, including the proposed DPT(s) deeds and the proposed Trustees of the trust(s).

Council acknowledged receipt of the letter and confirmed that the Government of Anguilla accepted the authority delegated and the conditions outlined in paragraphs 4, 5 and 6 of the Minister's letter. HE The Governor would write to Minister Duddridge to confirm this.

Following this confirmation the Chief Minister would be in a position to sign the

instrument of accession on behalf of Government to accede to and ratify the ECAMC Agreement.
