EX MIN 16/190 EX MEM 16/107 ANGUILLA AIR AND SEA PORTS AUTHORITY (AASPA) – 2016 BUSINESS PLAN

Parliamentary Secretary remained in attendance.

Further to EX MIN 16/190 of 24th March 2016, Council agreed that the Honourable Chief Minister and Minister of Finance should write to the Chairperson, AASPA and confirm approval for the AASPA 2016 Business Plan with conditions as outlined below:-

- 1. the AASPA makes every effort to implement and collect all the fees, charges and tariffs as approved by the Government of Anguilla and in accordance with the approved Tariff Book 2014/15, the Anguilla Air and Sea Ports Authority Act and Regulations and the Laws of Anguilla;
- 2. the AASPA shall not undertake any borrowing during the course of 2016 without dialogue, advice and the explicit approval of the Government of Anguilla;
- 3. the AASPA will make every effort to be self-sustaining, whilst reducing its debt, liabilities and unpaid bills during the course of 2016;
- 4. the AASPA will submit monthly financial reports to MICUHAFIT and MFEDICTLP no more than two weeks after the end of each month. The monthly reports should include appropriate details of all revenue and expenditure items as directed by the Permanent Secretary Finance;
- 5. the AASPA will submit Minutes of Board meetings to the portfolio Ministry, MICUHAFIT no later than one month after each meeting;
- 6. submission of all outstanding annual reports and audited statements by September 2016. That is, the AASPA should aim to be in compliance with section 32 of the AASPA's Act by September 2016;
- 7. the AASPA shall not undertake any major capital works or expenditure without dialogue, advice and approval from Government;
- 8. the AASPA shall work collaboratively and in accordance with the GoA's medium and long terms plans for strategic and tactical port development and operations and

9. the AASPA shall remain guided and act in accordance with the Fiscal Responsibility Act and the Framework for Fiscal Sustainability and Development.

EX MIN 16/202 PRESENTATION BY THE CANCER CENTRE EASTERN CARIBBEAN AND THE CANCER CENTRE, ANGUILLA (TCCEC)

Parliamentary Secretary remained in attendance. Dr Bonnie Richardson Lake, PS, HSD, Dr Tom McGowan, Medical Director, TCCEC, Dr Conville S. Brown, Chairman and CEO, TCCEC and Mr Henry J. Hazel, Senior Executive Officer, TCCEC joined the Meeting.

Dr Conville S. Brown, Chairman and CEO, TCCEC gave a power point presentation on the Cancer Centre Eastern Caribbean and the Cancer Centre, Anguilla. He indicated that TCCEC is the result of an OECS Head of Authority Mandate to develop a State of the Art Cancer and Cardiac Care Service to serve the people of the organisation of the Eastern Caribbean State using his Hub and Spoke Model. He further indicated that the TCCEC Hub in Antigua will provide Radiation Therapy while the OECS Member States, The Spokes, will be assisted by TCCEC where needed to establish a cost saving, robust oncology service so that Oncology Consultants, Clinics and Chemotherapy can be administered at home especially at the Government's facility for Government patients – The Cancer Centre Anguilla at the Princess Alexandria Hospital, Anguilla.

Council noted that the TCCEC was intended at inception and mandated by the OECS Heads of Authority in 2009, to serve the people of the OECS in the most cost effective and affordable manner as they continue the fight against the ravages of Cancer in our people and countries.

Council thanked the officials for a comprehensive presentation.
