EX MIN 16/226 EX MEM 16/129 ADDITIONAL SUPPORT FOR THE ANGUILLA SUMMER FESTIVAL 2016

- (iv) agreed that a separate paper setting out the development of an economic residency programme should be submitted to Executive Council for consideration in due course.

EX MIN 16/235 <u>INF 16/02 FOR INFORMATION: FINANCIAL SERVICES COMMISSION</u> 2016 BUDGET AND WORK PLAN

Council noted that the above paper was submitted to Executive Council on Thursday, 11th February 2016 for information. However, a record of the appropriate minute was inadvertently omitted from the Executive Council Minutes. Council agreed the following should be recorded in the Minutes:-

Council:-

- (a) noted the proposed 2016 Budget and Work Programme for the Anguilla Financial Services Commission (AFSC);
- (b) noted the AFSC's ambition to seek Ministerial support for enhancements to legislation during 2016 including:
 - i. <u>Investment Business Act, Regulations and Code</u>. This will create an opportunity to attract high-quality new financial services businesses to Anguilla and, at the same time, enhance Anguilla's international reputation by filling a regulatory gap that currently allows Anguillian companies to carry on unregulated high-risk investment business;
 - ii. Mutual Funds Act, Regulations (including fees and forms) and Code.
 This will replace existing inadequate and dated legislation with
 modern competitive legislation. The legislation will be separate
 from, and complementary to, the Investment Business Act; and
 - iii. new Captive Insurance Act, Regulations (including fees and forms) and Code. This will replace existing broad legislation that regulates all sectors of insurance with bespoke competitive legislation that will regulate only captive insurers. The legislation will be separate from, and complementary to, uniform legislation to regulate domestic insurers that is proposed as part of the ECCU's single insurance market project.
- (c) further noted that the 2016 Budget and Work Programme would be tabled in the House of Assembly for the information of legislators and the public.
