# EX MEM 16/175 REQUEST UNDER LEASE OF CROWN LAND TO MAKE STRUCTURAL ALTERATIONS/ADDITIONS TO BUILDING – CICELYN CARTY – PROPERTY DESCRIBED AS REGISTRATION SECTION NORTH, BLOCK 58815 B, PARCEL 300, CONTAINING 0.25 ACRE

Hon Parliamentary Secretary remained in attendance. Mr Foster Rogers, PS, EDICTLP joined the Meeting.

Council considered and supported the recommendations as outlined below:-

- (i) Cicelyn Carty has been living at the referenced location for almost twenty (20) years and has made improvements to the property. Even though the current lease is silent on who owns the improvements at the end of the lease, it would be unreasonable and immoral to dispossess the family of property that they constructed over the last twenty (20) years. In light of this, it would be unreasonable for the improvements to be reverted to the lessor;
- (ii) the lease should be calculated on land only;
- (iii) negotiations to be entered into with Cicelyn Carty with a view to entering into a purchase arrangement of some sort, whether on a lease-to-own basis or outright purchase. If Mrs. Carty is willing to purchase, the property should be sold to her at market value; excluding the improvements; and
- (iv) this matter with Cicelyn Carty should not be used to extend the same privileges to other individuals but the Government would need to look at them on a case by case basis and a policy developed to deal with such matters.

Council mandated the PS, EDICTLP to submit a draft policy on Crown leases/Investment in Crown property to Executive Council by the end of July 2016 for consideration.

Hon Parliamentary Secretary remained in attendance. Mr Larry Franklin, PS, MICUHAFIT, Mrs Evelyne Apire-Hodge, CEO, Water Corporation of Anguilla and Mr Mark Romney, Deputy Chairman, Water Corporation of Anguilla joined the Meeting.

Council noted the power point presentation on the Water Corporation of Anguilla by Mrs Evelyne Apire-Hodge, CEO, Water Corporation of Anguilla.

#### Council:

- (a) endorsed the Water Corporation of Anguilla's Business Plan with the following conditions:-
- 1) the WCA makes every effort to collect all of the approved fees, charges and tariffs;
- 2) the WCA shall not undertake any borrowing during the course of 2016 without dialogue, advice and the explicit approval of the Government of Anguilla;
- 3) the WCA will make every effort to be self-sustaining, whilst reducing its debt, liabilities and unpaid bills during the course of 2016;
- 4) the WCA will continue to submit monthly financial reports to MICUHAFIT and MFEDICTLP no more than two weeks after the end of each month. The monthly reports should include appropriate details of all revenue and expenditure items as directed by the Permanent Secretary Finance;
- 5) the WCA will continue to submit Minutes of Board meetings to the portfolio Ministry, MICUHAFIT no later than one month after each meeting;
- 6) submission of all outstanding annual reports and audited statements by December 2016. That is, the WCA should aim to be in compliance with sections 20 22 of the WCA's Act by December 2016;
- 7) the WCA shall not undertake any major capital works or expenditure without dialogue, advice and approval from Government;
- 8) the WCA shall work collaboratively and in accordance with the GoA's medium and long terms plans for the development of the water sector development priorities; and

- 9) the WCA shall remain guided and act in accordance with the Fiscal Responsibility Act and the Framework for Fiscal Sustainability and Development.
- (b) noted that the Minister with responsibility for Water has to consider and approve the AASPA 2016 business in accordance with section 16 of the Water Corporation of Anguilla Act;
- (c) endorsed the 2016 estimates of recurrent and capital expenditure for the WCA and noted that the conditions for the approval of the 2016 Business Plan are applicable to the approval of the estimates and that the Minister with responsibility for Finance has to consider and approve the estimates in accordance with section 64 of the Financial Administration and Audit Act; and
- (d) noted that the Minister with responsibility for Water in accordance with section 64(5) of the Financial Administration and Audit Act has to lay the 2016 estimates for the Water Corporation of Anguilla before the House of Assembly after approval of the estimates by the Minister of Finance and should endeavour to lay the estimates at the next sitting of the House of Assembly or soon thereafter.

Council further noted that the Water Corporation should engage in discussions with the Government of Anguilla with respect to:-

- (i) the submission of detailed proposals for the amendment of the Water Corporation of Anguilla Act;
- (ii) authority being given to undertake investigations pertaining to Water Corporation of Anguilla meters and infrastructure on private property;
- (iii) the transfer and/or lease of remaining land assets pertaining to the former Water Department;
- (iv) consideration of changes to the tariff structure and fees;
- (v) completion of the Water and Wells Regulations; and
- (vi) opportunities to provide water services to medium and large hotel properties.

Council thanked the Officials for a comprehensive presentation, and for their hard work.
