Council agreed that it was necessary to have a wider discussion with the PS, ELSYC, the Chief Project Officer, PS, MICUHAFIT and other finance officials concerning sourcing funds to enable this project to proceed and the implications of this for other planned projects in the 2016 Budget. The discussion would enable officials to consider the prioritisation of projects i.e. the current state of projects; what projects are currently on the way; what sums have been committed to and those remaining, and what could be progressed or delayed.

Council acknowledged that the Anguilla Summer Festival was Anguilla's main cultural showcase. Council noted the large amount still owing for outstanding bills for the 2015 festival.

Ministers of Government expressed the view that the GoA was obligated to ensure that the Anguilla Summer Festival takes place. With this in mind, Council agreed that the MFEDICT should allocate an additional EC\$600.000 to support the Anguilla Summer Festival 2016.

HE The Governor noted that this additional sum was not budgeted for in the 2016 Budget, and that the advice provided to Council did not make clear from where these funds would be sourced.

Council noted that the DOVE Centre at the Alwyn A. Richardson Primary School catered to students with multiple and profound disabilities and that the Centre was

currently at capacity because of the closure of the Blossom Centre which provided these specialised services, and the growing population of children in need of such services.

Council therefore approved the establishment of the Dove Centre II on the grounds that:-

- (i) there is a duty to provide educational opportunities to all children;
- (ii) the existing Centre cannot adequately accommodate all children in need of its specialist services; and
- (iii) the effectiveness of the programme at the Centre is being compromised by the existing circumstances.

 - whether, in regard to liability issues in relation to construction and operation of the race course and relevant facilities, it would be more prudent to lease the proposed property or enter into a Memorandum of Understanding (MOU) with Anguilla Motor Sports with regard to development; and
 - b) whether it is imperative for an insurance policy to be in effect at this time prior to execution of any of the above documents or when the facility is ready for operation.
