1. Mr. Duquaine Brooks

Council:-

- (a) agreed that the appeal against planning permission from Mr. Duquaine Brooks to construct a Commercial Complex/Gym in The Valley on Crown lands described as Block 48814B, Parcel 270 should not be allowed in light of the fact that the parcel in question is crossed by a natural ghaut which has serious implications for flooding in the area;
- (b) agreed that the parcel of land should always be under the control of the Government and should also be declared as open space on the land register and development to be prohibited thereon; and
- (c) further agreed that Mr. Duquaine Brooks should consider an alternate site for this development.

2. Zarna Brokerage & Trucking

Council:-

- (a) agreed that the appeal against planning permission from Zarna Brokerage & Trucking to construct a Commercial Complex in The Valley on Crown lands described as Block 48814B, Parcel 270 should not be allowed in light of the fact that the parcel in question is crossed by a natural ghaut which has serious implications for flooding in the area;

 - (iii) the portable toilet is to be constructed within a façade to ensure that its appearance is in keeping with the amenity of the area;
 - (iv) running water shall be provided for the operations of the food van and for patrons using the portable toilet from the public water supply;
 - (v) Mr. Connor shall be responsible for ensuring that the premises of The Valley Primary School are cleared of any wastes and refuse resulting from patrons of his business; and
 - (vi) this approval is for a period of two years. After this period the operations of the food van will be reassessed to ascertain if the Government would allow for the operations to continue for another period. Permission shall not be granted for more than two years at a time.

5. **Mr. Neville Goddard**

Council:-

- (a) noted an appeal against planning permission from Mr Gregory Martin, Agent for Mr. Neville Goddard to operate a Food Van at Meads Bay on a Parcel of land described as Block 17910B, Parcel 133; and
- (b) agreed that the matter should be deferred for a site visit by Members of Executive Council.

6. **Ms. Gecheal Richardson**

INF 16/06 INFORMATION NOTE:- NATIONAL FUNERAL FOR THE LATE MS. ISALEE HARRIGAN IN RECOGNITION OF HER INVALUABLE CONTRIBUTION TO ANGUILLA DURING THE REVOLUTION

Hon Parliamentary Secretary remained in attendance.

Council noted the passing of Ms. Isalee Harrigan of Pond Ground, East End on Monday, 4 July 2016. Ms. Harrigan, like many of the Anguillian women of that time, was very active and vocal in the many protests that followed the British invasion of the island on 19 March 1969. She was among some 27 Anguillian women featured in Mr Colville Petty's publication, 'Anguilla's Battle for Freedom 1967 – 1969' under the caption, 'Women in the Revolution'. The late Ms. Isalee Harrigan was awarded with the Anguilla Badge of Honour and Queens's Certificate in 2010 for her outstanding contribution to the Anguilla Revolution.

In keeping with the decision taken in EX MIN 14/612 (vii) of 2 October 2014 and EX MIN 15/535 of 23 September 2015, Council further noted that the Ministry of Home Affairs had begun the process of making arrangements which would include:-

- (i) the holding of a National Funeral for the late Isalee Harrigan in collaboration with the family;
- (ii) the publication of an official Statement of Condolence from the Government and people of Anguilla on the passing of this outstanding revolutionary;
- (iii) flags to be flown at Half Mast on the day preceding the funeral and on the day of the funeral until immediately following the funeral ceremony;
- (iv) a Police Guard of Honour to be drawn up at the Church and a contingent of uniformed officers to bear the body in and out of the church and at the graveside. Casket to be covered with the national flag; and
- (v) a contribution of EC\$5,000 towards the cost of the funeral expenses and EC\$3,000 towards the other expenses.
