STATUTES OF ANGUILLA, CHAPTER P20, SCHEDULE 2 (SECTION 27
(8)) – INVESTMENT OF THE PUBLIC SERVICE PENSION FUND

Council:-

- (i) noted the request to amend Schedule 2 (1) (Section 27 (8)) of the Pension Act to make provision for the Public Service Pension Fund to diversify its investments through the grant of loans to contributors, commencing 1 September 2016.
- (ii) agreed that the proposed time frame was not realistic as the proposed amendments had not been drafted and public consultations had not been carried out;
- (iii) noted that there exists no legislation in Anguilla providing for the effective regulation of either (a) pension schemes or (b) the operation of entities providing loans to the public, and therefore requested further advice from officials on how to provide improved safeguards to investors and borrowers;
- (iv) agreed, in light of (iii), that the proposed operational policy for the Public Service Pension Fund Loan Facility as outlined in appendix 1 of EX MEM 16/277, should be included as a schedule to the amended Act; and
- (v) asked the Attorney General's Chambers to draft the necessary amendment to the Act and associated schedule prior to Council approval and consultation.

Council agreed that the following persons should be exempted from the requirement of a work permit in accordance with Section 3 (g) of the Control of Employment Act:-

1. Edward Mejia Castillo	Mr. Mejia Castillo is a national of the Dominican Republic. He attended the ALHCS from September 2005 to July 2007. From 2010, Mr. Mejia Castillo has been issued a work permit exemption to work as a Plumber with Evcon Limited. That work arrangement has now ended and Mr. Jose Valera of South Hill, Anguilla, wishes to hire Mr. Mejia Castillo as a Labourer in his Recycling Company.
2. Kadisha Cupid	Ms. Cupid is a national of St. Vincent who has lived in Anguilla for the last nine years. Ms Cupid attended ALHCS from 2007-2014. Ms. Cupid lives in Anguilla with her mother and a younger brother. The breadwinner of the family, Horace Cupid, passed away in 2012. Ms. Cupid needs to work to assist with family responsibilities. She has been a recipient of a work permit exemption since 2015 with LIME. FLOW, now wishes to continue to employ Ms. Cupid as Back Office Support.
3. Jermila Monique Morson	Ms. Morson is a national of the United States. She lived in Anguilla in excess of five years, but was home schooled until 2003. Consequently,

her name does not appear in any of the Primary Schools records. She attended the ALHCS from 2003-2006 (ages 12-15) and then moved to the United States to complete her Secondary Education. Ms. Morson's documents show that Ms. Veda Belceta Richardson Frazier of Sandy Ground, Anguilla, Ms. Morson's grandfather, is a born citizen of Anguilla and that both of her parents are Belongers of Anguilla. The Anguilla Electricity Company, ANGLEC, advertised the position of PRO and after interviews Ms. Morson was the successful applicant. Ms. Morson is the holder of a Bachelor of Arts in English/Journalism and a Masters in Managerial Communication. An exemption from the work permit requirement is therefore being sought by ANGLEC for Ms. Morson. 4. Kemoloy Jessica Murphy Ms. Murphy is a national of Jamaica. Ms. Murphy has lived and worked in Anguilla for the last 10 years. She worked for Roy's for nine years. Last year Ms. Murphy received a job as Guest Services Attendant at Anacoana Boutique Hotel. Ms. Murphy is a student at University of the West Indies Open Campus since 2011 and has completed sixteen 3 credit Ms. Murphy was the recipient courses to date. of a work permit exemption in 2015. 5. Maikel King Antonio Mr. King Antonio is a national of Dominican Republic. He has been living in Anguilla for the last eleven years (from age 9). He attended Vivien Vanterpool Primary School from September 9, 2005 to July, 2008. He then moved on to the ALHCS and graduated in 2013. Mega Savers has advertised the position of Floor Supervisor and Mr. Antonio is the successful applicant. Consequently and exemption from the work permit requirement is being sought. 6. Samantha Patricia Johnson Ms. Johnson is a national of Jamaica. Ms. Johnson attended ALHCS from September 2005 to July 2010. She was employed by Best Buy Long Path as a Kitchen Helper and received a work permit exemption for this post. She has since left that job and is to be employed by Edwin Nichols of Cauls Bottom as a Domestic Helper. Consequently, a work permit exemption is being sought.

7. Kirmani Lloyd Honore	Mr. Honore is a national of Dominica. He has lived in Anguilla since the age of seven (7). Mr. Honore completed his Primary, Secondary and CAPE studies in Anguilla. In 2013 he graduated from sixth form. Mr. Honore has been offered a job at Island Time EBIZ Consulting Limited as Sales and Marketing Director. Consequently, an exemption from the work permit requirement is being sought.
8. Jomal Cean McBean	Ms. Mcbean is a national of Guyana. Ms Mcbean attended the ALHCS from January 2005 to July 2010. From 2011, Mr. Mcbean received a job at Dolce Vita as cook and then latter that season became Chef at the same establishment. His job letter speaks of his hard work, loyalty, dedication, organizational skills and honesty. For these reasons the Management wishes to keep Mr. Mcbean employed and is requesting that he be given an exemption from the work permit requirement.
9. Leslie Cedric Nanton	Mr. Nanton is a national of Canada. He is currently residing in Anguilla with his wife, Dr. Vonetta George, the Surgeon at the Princess Alexandra Hospital. Mr. Nanton, last year, took out a self-employed work permit as an entertainer. However, based on the criteria developed, spouses of persons who work in Essential Services may be eligible for the work permit exemption. Given that Mr. Nanton was self-employed and his work is based on a personal talent there was no need for an advertisement.
