- (iii) further noted that since their appointment to the Board, each of the above named persons has undergone extensive training in preparation for hearing cases. Any new member would be expected to undergo similar training. The current board has served two, two-year terms; and
- (iv) approved the Ministry of Health & Social Development's recommendation that the Board be reappointed given that the Board has served commendably and that they are the only persons in Anguilla currently trained to serve.

- (ii) agreed that in light of Mr Hughes' contributions to the people of Anguilla, that a contribution of EC\$26,882.00 should be given towards the cost of a National Funeral for the late legislator on Thursday January 5th 2017;
- (iii) agreed that the viewing of the body should take place at the Atlin Noraldo Harrigan Parliamentary Building on Thursday January 5, 2017 between the hours of 10am to 2pm.
