PRESENTATION BY MARITIME & COASTGUARD AGENCY (MCA) AND MICUHAFE

Hon Parliamentary Secretary remained in attendance. The following persons joined the Meeting:-

Council noted a comprehensive presentation by the Maritime & Coastguard Agency (MCA) Team. The main presenter, Ms Sarah Stride, Lead Auditor External Monitoring & Assurance stated that the visit was a follow-up on the visit undertaken in 2014. Ms Stride explained the importance of complying with the IMO Instruments Implementation Code (III Code) in order to meet obligations as responsible flag, port and coastal States. She indicated that the Agency was working with the MICUHAFE on key MCA Projects which include:-

1) <u>Maritime Obligations and Reduction in Contingent Liability</u>

The MCA would:-

- (a) assist in developing a gap analysis and discuss practical solutions;
- (b) provide legal assistance to review current maritime legislative regime and draft any relevant domestic legislation;
- (c) provide specialist technical support for marine surveyors and ferry operators; and
- (d) in 2019, undertake an assurance audit in preparation for the IMO audit scheduled for 2020.

- 2) <u>SAR Capability Review</u>
- (a) seek to gain an understanding of current practices in Anguilla;
- (b) review potential new technology and equipment relevant and cost effective to use and
- (c) undertake a SAR capability review in Anguilla currently programmed for November 2017 (this is being looked at to try to bring this date forward).

Ms Stride pointed out that co-operation of all stakeholders was important in moving the projects forward.

Council:-

- (i) acknowledged the implications for Anguilla of non-compliance;
- (ii) recognised the need for interdepartmental co-operation to achieve III Code compliance; and
- (iii) supported robust action where required, to ensure lifeline vessel services meet requirements.

Council thanked the officials for their informative presentation.

INF 17/02 INFORMATION NOTE:- NATIONAL FUNERAL FOR THE LATE MS. FLOREL HARRIGAN IN RECOGNITION OF HER INVALUABLE CONTRIBUTION TO ANGUILLA DURING THE REVOLUTION

Council noted the passing of Ms. Florel Harrigan of Island Harbour on Friday 14th April 2017. Ms. Harrigan was the sister of the late revolutionary leader, Mr James Ronald Webster. She stood in the frontlines during the revolution in 1967 and was responsible for hiding Mr Webster, feeding him and taking information to him while in hiding. Ms. Harrigan was very conscious of this national responsibility and would often tie sheep around the bush covered hole, which concealed Mr Webster to distract the British paratroopers in search of him.

The late Ms. Florel Harrigan was awarded with the Anguilla Badge of Honour and Queen's Certificate in 2013 for her outstanding contribution to the Anguilla Revolution.

In keeping with EX MIN 14/612 (vii) of 2nd October 2014 and EX MIN 15/535 of 23rd September 2015, the Ministry of Home Affairs has therefore begun the process of making arrangements which would include:-

(i) the holding of a National Funeral for the late Florel Harrigan on Saturday 29th April 2017, in collaboration with the family. The funeral will take place at the Hilltop Baptist Church in Island beginning at 10:00 am;

- (ii) the publication of an official Statement of Condolence from the Government and people of Anguilla on the passing of this revolutionary;
- (iii) flags to be flown at Half Mast on the day preceding the funeral and on the day of the funeral until immediately following the funeral ceremony;
- (iv) a Police Guard of Honour to be drawn up at the Church and a contingent of uniformed officers to bear the body in and out of the church and at the graveside. Casket to be covered with the national flag; and
- (v) a contribution of EC\$5,000 towards the cost of the funeral expenses and EC\$3,000 towards the other expenses.
