EX MEM 17/116 EXEMPTION FROM THE WORK PERMIT REQUIREMENT

Hon Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained in attendance.

Council agreed that the nineteen (19) persons on the attached list should be exempted from the work permit requirement under Section 3 (g) of the Control of Employment Act. Council further agreed that the criteria set out below should form the basis of the discussion and any exemption that may result.

- 1. the exemption must be in relation to a job that has been advertised, and not for the purpose of finding a job;
- persons working for a non-profit, cultural, educational or charitable body; employment as a voluntary worker which covers certain unpaid workers for a charity, a voluntary organisation, an associated fund-raising body or a statutory body;

- persons who have attended primary and secondary school in Anguilla covering a minimum of 5 years. Original school letters must be provided; and
- 4. spouses of persons in essential services, including but not limited to medical doctors and the aviation industry. However, the exemption <u>must</u> be in relation to a job being advertised for which there is no qualified Anguillian who can legitimately fill the position.

Recurrent Expenditure realised an actual of EC\$45.5m from a projected estimate of EC\$48.3m, an underspend of 6%.
