### EX MIN 17/196 EX MEM 17/120 NEW CONTRACT FOR ANGUILLA LOTTERY GAMING CO LTD

Hon Parliamentary Secretary remained in attendance. Mr Brian Deadman, Financial Adviser to the GoA joined the Meeting.

Council agreed that:-

- (i) an exclusivity clause for the Anguilla Lottery Gaming Co Ltd must not be included in any future contract with the Government of Anguilla;
- (ii) the tenure of any future contract with the Government of Anguilla and the Anguilla Lottery and Gaming Co Ltd should be for ten years with an option for extension;
- (iii) a new licensing fee of EC\$100,000.00 should be charged;
- (iv) a new contract for the Anguilla Lottery Gaming Co Ltd should be approved effective 1 June 2017, subject to negotiating reasonable terms and conditions; and
- (v) the Government of Anguilla should make adjustments to laws and/or regulations to accommodate the above fee structure as may be necessary.

Council additionally agreed that recommendation 4 of EX MEM 17/120, which states, "A business licence fee of EC\$1,000.00 (belonger) and EC\$1,500.00 (non-belonger) should be charged for each lottery outlet. This fee is already accommodated in the legislation under the Fee Schedule of the above Act under Sections 3 and 6" should be revisited.

### EX MIN 17/200

### EX MEM 17/124 PROPOSALS FOR CHANGES TO IMMIGRATION POLICY

Hon Parliamentary Secretary remained in attendance. Financial Adviser to the GoA remained for discussion.

Council approved the proposed policy changes, as indicated below, on the grounds that they would facilitate ease of entry into Anguilla, especially for visitors who can provide some economic stimulus.

### (A) RELAXATION OF VISA REQUIREMENTS

- (i) Government will relax the visa requirements to enter Anguilla, for the following categories of persons:-
  - (a) third country nationals holding a valid visa from the United States, Canada or the United Kingdom; and
  - (b) third country nationals holding a valid residence permit from the United States, Canada or the United Kingdom.
- (ii) such persons, regardless of their country of origin, will be allowed to enter and remain in Anguilla without an Anguilla visitor's visa and may be allowed to remain for a period not exceeding 3 months.

### (B) SIMPLIFICATION OF ENTRY PROCESS

- (i) nationals of St Maarten/St Martin will be allowed to enter Anguilla using a machine readable national identification card and remain for up to 72 hours (3 days); and
- (ii) French Nationals who are visiting St Maarten will be allowed to enter Anguilla using a machine readable national identification card and remain for up to 24 hours (1 day).

### (C) LENGTH OF STAY ISSUED AT PORTS

- (i) all visitors entering Anguilla (including belongers born outside Anguilla with no proof of belonger status) will be given permission at the port to remain for a minimum of 30 days and a maximum of 90 days. Note however that Immigration Officers may exercise discretion and give less time, if circumstances should require less time; and
- (ii) persons born in Anguilla after 1982 who are not automatically belongers and who are travelling on non-BOTC passports or with no proof of belonger status may be given permission to enter and remain for up to one year. They will also be advised of the requirements to facilitate ease of entry into Anguilla.
