Further to EX MIN 17/115 of 23<sup>rd</sup> March 2017, Council noted a comprehensive Power Point presentation by Mr Claudel Romney, Managing Director, BDO on GoA's intended sale of shares in Anglec to offset some of its debt. Council would decide on the share valuation and the amount of shares to sell.

Following the presentation and discussion, Council agreed that:-

- (i) the PS, FIN should sign the Prospectus on behalf of the Government of Anguilla; and
- (ii) the Attorney General's Chambers should review the Prospectus.

The Hon Minister of Home Affairs and Education stated that Anglec was the only monopoly held by the Government of Anguilla, and she was concerned that the Government was prepared to give up all its interest in Anglec. She said that the GoA should have at least, retained a small percentage ownership. The Minister abstained from making a decision. Council noted her concern.

Council commended the BDO team and the Anglec Share Sale Committee for a job well done.

- 1. the exemption must be in relation to a job that has been advertised, and not for the purpose of finding a job;
- 2. persons working for a non-profit, cultural, educational or charitable body; employment as a voluntary worker which covers certain unpaid workers for a charity, a voluntary organisation, an associated fund-raising body or a statutory body;
- 3. persons who have attended primary and secondary school in Anguilla covering a minimum of 5 years. Original school letters must be provided;
- 4. spouses of persons in essential services, including but not limited to medical doctors and air traffic controllers. However, the exemption **must** be in relation to a job being advertised for which there is no qualified Anguillian who can legitimately fill the position; and
- 5. persons in the aviation industry.

Council agreed that the Inland Revenue Department Act, R.S.A. CI13, Certificate of Good Standing Regulations, 2012 should be amended to:-

- exclude minors, personal representatives (in their personal capacity) and the estates of deceased persons who are not registered as for tax purposes from producing certificates to the Registrar of Lands on submission of instruments of transfer;
- (ii) define tax as it relates to deceased persons; and
- (iii) require that, on the first Gazetting of the list of persons who have applied to the Court for Letters of Administration, that the Department of Inland Revenue, source said publication and publicise in the following Gazette publication of outstanding taxes owed to Government by each estate which is required to be paid by the personal representative in settlement of said outstanding taxes, and that the personal representative is responsible for finding out if there are any taxes owed by the deceased person.
