The Hon Deputy Governor said that he had circulated a recent draft copy of the Workplan 2018 – 2020. The DG stated that he needed clarity from GoA Ministers and Executive Council as to what the priority areas should be going forward.

- (i) ratified the decision taken by round robin on 31st October 2017 to amend the list previously agreed to give effect to certain items to be imported free of duty for the relief phase of the Hurricane Irma response, which should include the following:
 - a) vehicle windows; and
 - b) chain saws
- (ii) noted that the amended Regulation was passed in the House of Assembly on Thursday 2nd November 2017; and
- (iii) noted that the Customs Duty (Exemption) (Hurricane Irma Relief) (Amendment) Regulations, 2017 had been signed by HE The Governor on 31st October 2017.

EX MIN 17/511 EX MEM 17/310 TO REVIEW THE ISSUANCE OF VOLUME PURCHASE AGREEMENTS (CURRENTLY KNOWN AS BPAs) BY THE REGISTRY OF COMMERCIAL ACTIVITIES FOR THE INCORPORATION OF OCS AND IBCS

Hon Parliamentary Secretary remained in attendance.

Council:-

(i) commended the work undertaken to address a long standing issue and agreed to the proposed discounted pricing structure and conditions for incorporations of IBCs and COCs under the volume purchase scheme as proposed in Part II, 4;

- (ii) instructed the Attorney General's Chambers to begin drafting amendments to R.S.A. c. I20 International Business Companies Regulations R.R.A. I20-1, so that the Registrar may have the authority to extend the discounted pricing structure under VPAs to agents for the incorporation of IBCs; and
- (iii) further instructed the Attorney General's Chambers to review the current BPA agreement to ensure that any failure to perform duties under the contract by agents would attract the appropriate penalties.

Council additionally agreed that a broader view on the growth and development of the Financial Services Industry should be taken. A comprehensive strategy should be developed in consultation with the various stakeholders to set a clear direction going forward.
