Council noted that finance officials would attend the next Meeting of Executive Council on Thursday 18th January to give a rundown on the 2017 end of year financial position and to discuss preparation plans for the 2018 Budget.

EX MIN 18/04 ACCESS TO ANGUILLA FOR 2018 TOURIST SEASON

Hon Parliamentary Secretary remained in attendance. Mr Darren Forbes-Batey, Chief of Staff (CoS), Governor's Office joined the Meeting.

CoS reported on progress with UK funded programmes to repair infrastructure damaged by Hurricane Irma.

In terms of <u>the airport</u> the temporary Air Traffic Control Tower is functioning well. Night operations are, however, still not possible because of outstanding issues with fencing and lighting. Both matters are in hand and were being dealt with in accordance with ASSI Regulations.

In terms of <u>ferry access</u>, Council discussed the need to expedite the proposal for UK funding on Blowing Point and the corresponding site adjacent to the Princess Juliana Airport in St. Maarten. The Hon Chief Minister indicated he would have a word with the political directorate in St. Martin about who he should speak to directly. Council asked that this be expedited as quickly as possible. H.E. The Governor noted that he was ready to lend his weight to this vital work.

The CoS noted that the ATB, Parliamentary Secretary and officials were working together to formulate a proposal for UK's support to improve immediate air access into Anguilla and to support marketing initiative. He said that he and the Chairperson, ATB would finalise the proposal for presentation to the UK.
