EX MIN 18/44 EX MEM 18/28 AMENDMENT TO POLICY ON WORK PERMIT EXEMPTIONS

Hon Parliamentary Secretary and Ministerial Assistant to the Hon Minister, MHA remained in attendance. PS, MHA and Labour Commissioner (Acting) remained for discussion.

Council noted that in order to assist the decision making process in the granting of exemptions, the Ministry of Labour has adopted a policy which outlines categories of persons for whom exemptions should be granted that is used in making recommendations to the Governor in Council with regard to exemptions. The current categories and criteria are as follows:-

- a) The exemption must be in relation to a job that has been advertised, not for the purpose of finding a job.
- b) Persons working for a non-profit cultural, educational or charitable body; employment as a voluntary worker which covers certain unpaid workers for a charity, a voluntary organisation, an associated fund-raising body or a statutory body.
- c) Persons who have attended primary and secondary school in Anguilla covering a minimum of 5 years. Original school letters must be provided.
- d) Spouses of persons in essential services, including but not limited to medical doctors and air traffic controllers. Must be in relation to a job being advertised for which there is no qualified Anguillian who can legitimately fill the position.
- e) Persons in the aviation industry.
 - Council agreed to add other categories to the current categories to include the following persons:-
- f) Persons who are required to restore essential services including utility, transportation and telecommunication services in the six weeks immediately after a natural disaster, in the first instance.
- g) Persons who are British Overseas Territories Citizens (from territories other than Anguilla) who have obtained permanent residence status and renew it annually.
- h) additionally agreed that category d) above should be amended in part to read, "Spouses of persons in essential services, including but not limited to health care professionals and air traffic controllers".
