Council:-

- (i) noted the request for the GoA to pay off part of its payment arrears with part proceeds of the Policy Based Loan from the Caribbean Development Bank (CDB); and
- (ii) agreed that the GoA should repay EC\$17 million of these arrears, with part proceeds of the EC\$52 million Policy Based Loan from the CDB as follows:-

Anguilla Social Security Board: \$4.10 Health Authority: 4.28 Water Corp: 3.62 Civil Servants Deferred Salaries: 5.00

Total \$17.00 million

Council additionally noted that the 2018 Recurrent Expenditure Budget Estimate would increase to **EC\$224,886,994** and the amount to cover the arrears would be placed under the Ministry of Finance Budget.

H E The Governor asked the officials:-

- (i) to be mindful that CDB had to agree to the release of the EC\$52m and that these funds were not yet readily available;
- (ii) to note that the increase on the 2018 Estimates of Recurrent Expenditure would mean that they would not be able to pay down on the overdraft; and
- (iii) to recognise that the NCBA issue has pinned down the Ministry's capacity to get things accomplished.

The Governor commended the officials for understanding the importance of taking control of the arrears. He encouraged them to collect all the revenue they could as quickly as possible.
