#### EX MIN 19/43 **UPDATE ON THE ANGUILLA PROGRAMME**

Hon Parliamentary Secretary, Ministerial Assistant to the Hon Minister, MHA and Financial Specialist remained. Anguilla Programme Manager, Mr Darren Forbes-Batey joined.

Following from EX MIN 19/26 of 17 January, Council:

- (i) reiterated the urgent need to speed up delivery of all projects within the programme;
- (ii) noted the importance of GoA officials working collaboratively with the Programme Manager and his team to achieve this;
- (iii) noted that the current approved list of projects was estimated to cost around £75 million, £15 million more than the grant ceiling of £60 million;
- (iv) requested the Anguilla Programme Manager to work with GoA Ministers and senior planners to identify the actions including the phasing of projects needed to ensure total estimated spend fell within the grant limit;
- (v) noted the particular importance of getting work on the ALHCS started quickly; and
- (vi) agreed that an early conversation between the Hon Chief Minister and the UKG would be quite useful in making the case for additional funding.
